### THIRD AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES

THIS THIRD AMENDMENT TO AGREEMENT FOR GROUNDS MAINTENANCE SERVICES ("Third Amendment") is entered into by and between <u>CITY OF OCALA</u>, a Florida municipal corporation ("City"), and <u>PURE CUTS LAWN AND MAINTENANCE, LLC</u>, a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 88-4098034) ("Contractor").

**WHEREAS**, on February 21, 2024, City and Pure Cuts Lawn And Maintenance entered into an Agreement for Grounds Maintenance Services (the "Original Agreement"), City of Ocala Contract Number: PWD/240108 for a term of two (2) years from March 1, 2024, to February 28, 2026; and

**WHEREAS**, on March 21, 2024, City and Pure Cuts Lawn And Maintenance entered into First Amendment to Agreement for Grounds Maintenance Services to modify the locations to be serviced by Contractor (the "First Amendment"); and

**WHEREAS**, on April 30, 2024, City and Contractor entered into Second Amendment to Agreement for Grounds Maintenance Services to modify the locations to be serviced by Contractor (the "Second Amendment"); and

**WHEREAS**, City and Contractor now desire to further modify the locations to be serviced by Contractor as detailed in the Price Proposal attached to the Original Agreement, as amended, and incorporated herein as **Exhibit B – Third Amended Price Proposal**.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Third Amendment.
- 3. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL.** The document attached to the Original Agreement, as amended, as **Exhibit B Amended Price Proposal** is hereby deleted in its entirety and replaced with **Exhibit B- Third Amended Price Proposal**.
- 4. **NOTICES**. All notices, certifications or communications required by this Third Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:
