



### THIRD AMENDMENT FOR COOPERATIVE PURCHASING AGREEMENT FOR PUMP AND MOTOR REPAIR SERVICES

THIS THIRD AMENDMENT FOR COOPERATIVE PURCHASING AGREEMENT FOR PUMP AND MOTOR REPAIR SERVICES ("Third Amendment") is entered into by and between the CITY OF OCALA, a Florida municipal corporation ("City") and FLORIDA ARMATURE WORKS, a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN: 59-3263174) ("Contractor" or "Service Provider").

**WHEREAS**, on October 23, 2023, City and Contractor entered into a Cooperative Purchasing Agreement for Pump and Motor Repair Services (the "Original Agreement"), City of Ocala Contract Number: WRS/230667 for a term from August 25, 2023, to January 30, 2024; and

**WHEREAS**, on April 23, 2024, City and Contractor entered into a First Amendment to Agreement for Pump and Motor Repair Services (the "First Amendment"), to renew the term of the Original Agreement for the first of three (3) available one-year renewal periods; and

**WHEREAS**, on May 6, 2025, City and Contractor entered into a Second Amendment to Agreement for pump and motor services (the "Second Amendment"), to renew the term of the Original Agreement for the second of three (3) available one-year renewal periods; and

**WHEREAS**, City and Contractor now desire to extend the Original Agreement for the third and final one-year renewal period available under the terms of the Original Agreement.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement, as amended, between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Third Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional (1) one-year term beginning JANUARY 31, 2026, and terminating JANUARY 30, 2027.
4. **COMPENSATION.** City shall pay Contractor a price not to exceed the maximum limiting amount of FIFTY THOUSAND, AND NO/100 DOLLARS (\$50,000) (the "Contract Sum") as full and complete compensation for the timely and satisfactory performance of services.
5. **NOTICES.** All notices, certifications or communications required by this Third Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the Agreement that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this Third Amendment for all purposes.
8. **LEGAL AUTHORITY.** Each person signing this Third Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Third Amendment.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. ### **Consequences of changing your mind**
