



## FIRST AMENDMENT TO AGREEMENT FOR UNDERGROUND CONDUIT INSTALLATION

THIS FIRST AMENDMENT TO AGREEMENT FOR UNDERGROUND CONDUIT INSTALLATION ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **AMERICAN CABLE ELECTRIC, LLC**, a limited liability company duly organized in and authorized to do business in the state of Florida (EIN: 86-1758243) ("Contractor").

**WHEREAS**, on January 15, 2025, City and Contractor entered into an Agreement for Underground Conduit Installation (the "Original Agreement") for a term of two (2) years from January 8, 2025 to January 7, 2027; and

**WHEREAS**, City and Contractor now desire to revise **Exhibit B – Price Proposal** to include additional line items.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this First Amendment.
3. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL.** The document attached to the Original Agreement as **Exhibit B – Price Proposal** is hereby deleted and replaced in its entirety with **Exhibit B – Amended Price Proposal**, attached hereto.
4. **COMPENSATION.** The highest total compensation payable to Contractor by City for the satisfactory performance of services in compliance with Exhibit A – Scope of Work and the Contract Documents shall be **ONE MILLION SIX HUNDRED THOUSAND AND NO/100 DOLLARS (\$1,600,000)** over the Contract Term. Compensation paid to Contractor shall be paid in accordance with the unit pricing schedule set forth below in **Exhibit B – Amended Price Proposal**.
5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

8. **LEGAL AUTHORITY.** Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.





## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**
