

FOURTH AMENDMENT TO AGREEMENT FOR STORMWATER GROUNDS MAINTENANCE SERVICES – SOUTH

THIS FOURTH AMENDMENT TO AGREEMENT FOR STORMWATER GROUNDS MAINTENANCE SERVICES - SOUTH ("Fourth Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), and **TOP QUALITY LAWN MAINTENANCE**, **LLC**, a limited liability company duly organized and authorized to do business in the state of Florida (EIN# 37-1699878) ("Vendor").

WHEREAS, on December 18, 2019, City and Vendor entered into an Agreement for Stormwater Grounds Maintenance Services - South (the "Original Agreement"), City of Ocala Contract No.: PWD/190727 for a term of three (3) years, December 18, 2019 to December 17, 2022; and

WHEREAS, on July 1, 2022, City and Vendor entered into a First Amendment to amend Exhibit B – Price Proposal to revise unit pricing for the remainder of the initial term (the "First Amendment"); and

WHEREAS, on December 2, 2022, City and Vendor entered into a Second Amendment for Stormwater Grounds Maintenance Services – South to amend Exhibit B – Price Proposal and extend the term of the Original Agreement as amended, for the first of two available renewal terms, from December 18, 2022 to December 17, 2023 (the "Second Amendment"); and

WHEREAS, on December 4, 2023, City and Vendor entered into a Third Amendment for Stormwater Grounds Maintenance Services – South to extend the term of the Original Agreement for the final available one-year renewal period; and

WHEREAS, City and Vendor now desire to further modify line items and pricing previously agreed upon by Vendor as set forth in the **Exhibit B – Amended Price Proposal** attached to the Original Agreement, as amended.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

- 1. **RECITALS.** City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Fourth Amendment.
- 4. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL.** The document attached to the Original Agreement, as amended, as Exhibit B Amended Price Proposal is hereby deleted and replaced, in its entirety, with the document attached to this Fourth Amendment as **Amended Exhibit B Price Proposal.**
- COMPENSATION. City shall pay Vendor an amount not to exceed the maximum limited amount of FIVE HUNDRED THIRTY-TWO THOUSAND, THREE HUNDRED FORTY-NINE NO/100 DOLLARS (\$532,349) over the initial contract term in accordance with the unit pricing set forth in Amended Exhibit B Price Proposal. The pricing in this Agreement shall only be adjusted by written amendment executed by both parties.



6. **NOTICES**. All notices, certifications or communications required by this Fourth Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the Fourth Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Fourth Amendment for all purposes.
- 7. **LEGAL AUTHORITY**. Each person signing this Fourth Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Fourth Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Fourth Amendment.
