



## SECOND AMENDMENT TO AGREEMENT FOR FENCING INSTALLATION SERVICES – CITYWIDE

THIS SECOND AMENDMENT TO AGREEMENT FOR FENCING INSTALLATION SERVICES – CITYWIDE ("Agreement") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **CHARLES WHITE FENCE, INC.**, a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN: 20-8367837) ("Contractor").

**WHEREAS**, on January 11, 2023, City and Contractor entered into an Agreement for Fencing Installation Services (the "Original Agreement") for a two (2) year term starting from January 4, 2023, through January 3, 2025; and

**WHEREAS**, on February 20, 2025, City and Contractor Entered into a First Amendment for Fencing Installation Services (the "First Amendment") extending the Original Agreement for the first of two available one (1) year terms available under the Original Agreement, from January 4, 2025 to January 3, 2026; and

**WHEREAS**, City and Contractor now desire to add an additional \$45,857 to the Contract Sum of the Original Agreement, as amended, increasing the expenditure over the Contract Term to \$242,308.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
3. **COMPENSATION.** Contractor shall be paid a price not to exceed the maximum limiting amount of **TWO HUNDRED FORTY-TWO THOUSAND, THREE HUNDRED EIGHT AND NO/100 (\$242,308)** (the "Contract Sum") over the Contract Term as full and complete compensation for the timely and satisfactory performance of services.
4. **NOTICES.** All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

7. **LEGAL AUTHORITY.** Each person signing this Second Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

### **All notices and disclosures will be sent to you electronically**

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. If you do not agree with this process, please let us know as described below. ### **To withdraw your consent with City of Ocala - Procurement & Contracting**
