



FIRST AMENDMENT TO AGREEMENT FOR COMMERCIAL GRADE LIQUID SODIUM HYPOCHLORITE SUPPLY AND DELIVERY

THIS FIRST AMENDMENT TO AGREEMENT FOR COMMERCIAL GRADE LIQUID SODIUM HYPOCHLORITE SUPPLY AND DELIVERY ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), and **ODYSSEY MANUFACTURING COMPANY**, a foreign for-profit corporation duly organized in the state of Delaware and authorized to do business in the state of Florida (EIN: 65-0846345) ("Vendor").

WHEREAS, on September 20, 2023, City and Vendor entered into an Agreement for the provision of commercial grade liquid sodium hypochlorite (the "Original Agreement"), City of Ocala Contract Number: WRS/230584, for a term of two (2) years starting October 1, 2023, through September 30, 2025; and

WHEREAS, City and Vendor now desire to renew the Original Agreement for the first of two one-year renewal terms available under the Original Agreement and to increase the Pricing Schedule by 2.3% for the Renewal Term.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Vendor agree as follows:

1. **RECITALS.** City and Vendor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this First Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional (1) one-year term beginning on **OCTOBER 1, 2025**, and terminating **SEPTEMBER 30, 2026**. Thereafter, this Agreement may be renewed for **ONE (1)** optional **ONE (1) YEAR** period by written consent between City and Vendor.
4. **COMPENSATION.** City shall pay Vendor a price not to exceed the maximum limiting amount of **SIX HUNDRED TWENTY-FIVE THOUSAND AND NO/100 DOLLARS (\$625,000)** (the "Contract Sum") for the satisfactory performance of services over the Renewal Term. Compensation paid to Vendor shall be paid in accordance with the pricing schedule set forth below:

5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Further, a duplicate or copy of the First Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original First Amendment for all purposes.
8. **LEGAL AUTHORITY.** Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
