Rationale and Methodology:
The Transportation Department and City of Ocala requests approval to renew Bid 3980GM, which provides gasoline and diesel fuel for both The School Board of Marion County, Florida and City of Ocala.

Financial History and Term/Time Frame:
The supporting vendors are: Colonial Oil Industries, Inc of Savannah, GA; Mansfield Oil Company of Gainesville, Inc. of Gainesville, GA; and Petroleum Traders Corporation of Ft. Wayne, IN. The term of this bid renewal is July 1, 2024 through June 30, 2025. Resources required for this bid renewal are approximately \$3,500,000.00 as a yearly estimate for the District. At the time of submitting this agenda item \$2,375,000.00 has been encumbered in the current bid term.

Effect of Action/Results:
By approving this renewal, this bid will continue to provide gasoline and diesel fuel, supplying diesel generators, boilers, buses, and other vehicles used by students and staff throughout the District.
