

SECOND AMENDMENT TO COOPERATIVE PURCHASING AGREEMENT FOR THE PROVISION OF FIRE EQUIPMENT PARTS, SUPPLIES, AND RELATED PRODUCTS AND SERVICES

THIS SECOND AMENDMENT TO COOPERATIVE PURCHASING AGREEMENT FOR THE PROVISION OF FIRE EQUIPMENT PARTS, SUPPLIES, AND RELATED PRODUCTS ("Second Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **MUNICIPAL EQUIPMENT COMPANY, LLC,** a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 59-3624496) ("Contractor").

WHEREAS, on September 11, 2022, City and Contractor entered into a Cooperative Purchasing Agreement for the Provision of Fire Equipment Parts, Supplies and Related Products and Services (the "Original Agreement"); and

WHEREAS, on August 3, 2023, City and Contractor entered into a First Amendment to Cooperative Purchasing Agreement for the Provision of Fire Equipment Parts, Supplies and Related Products and Services (the "First Amendment") to extend the Original Agreement for an additional term from August 1, 2023 through July 31, 2025; and

WHEREAS, City and Contractor now desire to renew the Original Agreement for an additional

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

- 1. **RECITALS**. City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein its entirety and remains in full force and effect except for those terms and conditions expressly amended by this Third Amendment.
- 3. **RENEWAL TERM.** The Original Agreement, as amended, is hereby renewed for a **TWO (2) YEAR** term commencing **AUGUST 1, 2025,** and ending **JULY 31, 2027**.
- 4. **COMPENSATION.** City shall pay Contractor a price not to exceed **FOUR HUNDRED FORTY THOUSAND AND NO/100 DOLLARS (\$440,000)** (the "Contract Sum") over the Renewal Term as full and complete compensation for the timely and satisfactory provision of services as described in the Original Agreement and **Exhibit C Lake County Contract Modifications.**
- 5. **NOTICES.** All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the Agreement that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Agreement for all purposes.
- 8. **LEGAL AUTHORITY**. Each person signing this Second Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment.
