10i. Approve the purchase of new portable radios for Ocala Police Department, Ocala Fire Rescue, and Ocala Electric Utility utilizing State of Florida's alternative source agreement with Motorola Solutions, Inc. in the amount of \$5,952,904

Meghan Mercer, Dana Lucas, 2150 15th Avenue, Vero Beach, FL, spoke on behalf of Communications International (integrator for L3 Harris). She requested City Council defer the action to allow Communications International the opportunity to schedule a meeting with City leadership to discuss the proposed purchase. Furthermore, she requested the City correct false statements on the Procurement Expectations Form.

Procurement & Contracting Officer Daphne Robinson spoke on the procurement procedures. She defined a cooperative purchase, which evaluates cost, quality, delivery and sustainability. Furthermore, the Ocala Police Department noted significant advantages with the selected vendor known as Motorola Solutions, Inc., compared to Communications International.

Police Information Systems Director Joshua Sasso stated the City has a great twenty-year business relationship with Motorola Solutions, Inc. (Motorola). The vendor is integrated into the 911 system and offers local Motorola support. To note, the vendor owns the Vespa software program, which OPD utilizes for emergency services. Motorola's ownership of the software provides various integration options to support public safety efforts. He cautioned on utilizing multiple vendors to avoid public safety issues and liability concerns.

Furthermore, he confirmed the radios are purchased directly from Motorola and outdated equipment is recycled to other departments to support cost saving efforts. He assured the two vendors were thoroughly evaluated; recommends selecting a "sole vendor", such as Motorola, to support public safety efforts.

Council Member Hilty expressed concern regarding Motorola's proposed price and the City's utilization of the Exception Request Form.

Ms. Robinson confirmed the Exception Request Form has been utilized by the City since 2022. The City allows departments to provide procurement requests with justification. The Procurement Department weighs the pros and cons of each request before selecting a vendor. The proposed amount (\$5,952,904) will be paid over a five-year period, to minimize budget impacts.

Mr. Sasso confirmed L3 Harris has partnerships with several government counties/municipalities, such as Levy County. To note, Levy County reported the vendors' products work fine; however, OPD values the service/product quality received from Motorola and reemphasized the importance of a single provider to minimize potential compatibility issues.

Council President Dreyer commended the Procurement Department for taking into consideration the departments needs when evaluating requests, not selecting a vendor based solely on price.

Council Member Musleh thanked the City for clarifying the vendor selection.

12. City Manager's Report

- Marion County public hearings for EMS impact fees/transportation impact fees scheduled for Friday, May 23, 2025, at 1:30 pm and 2:00 pm

City Manager Pete Lee reported Marion County is hosting public hearings for EMS impact fees/transportation impact fees on May 23, 2025. The City is working on drafting local agreements prior to the public hearings. The draft agreements will address requests made by the County, and City Council will be briefed individually before the public hearings.

- Ordinance for removal of fluoride from City water supply to be introduced next meeting in accordance with new State law to be enacted on July 1, 2025

City Manager Pete Lee reported a new State Bill was passed regarding the removal of fluoride from City water, which will take effect on July 1, 2025. The City will introduce an ordinance at the next meeting to comply with the new State law.

13. Ocala Police Department Report

- Overview of Crime and Traffic Stops

Police Chief Mike Balken reported on the Police Departments efforts for a two-week period, May 5, 2025 to May 18, 2025: 23 significant crimes, 194 arrests, 120 FIRs, and 1,112 traffic stops. The department is utilizing social media platforms to report on public safety efforts.

14. Ocala Fire Rescue Department Report

- Unit Responses

Fire Chief Clint Welborn reported on unit responses for a two-week period, May 6, 2025 to May 19, 2025. The three busiest units: Fire Rescue One (155-unit responses), Fire Engine Four (90-unit responses), and Ladder 3 (90-unit responses).

- Service calls update

Fire Chief Clint Welborn reported on call type spotlights for a two-week period, May 6, 2025 to May 19, 2025: motor vehicle accidents 70, structure fires 4, and community paramedicine/core 70, and 938 calls for service (9,522 calls-to-date).

- Department Highlights

Fire Chief Clint Welborn reported the department responded to several incidents: gas leak incident on NE 36th Avenue (May 8, 2025), plane crash (May 7, 2025), vehicle building crash (May 10, 2025), and I-75 motor vehicle accident (May 14, 2025). Furthermore, the Department participated in two events: Fallen Officer Memorial (May 15, 2025) and EMS Week (May 18, 2025 to May 24, 2025).

15. City Attorney's Report

15a. Approval of and entry into a proposed Settlement Agreement in the matter of Art Rojas & Lucinda Hale v. City of Ocala, currently pending on appeal before the United States Court of Appeals for the Eleventh Circuit

City Attorney Sexton discussed the approval of a settlement in the matter of Art Rojas & Lucinda Hale vs. City of Ocala. The plaintiffs have agreed to forego any entitlement for an award of attorney's fees. He requested City Council approve the proposed settlement.

Kent Guinn, 320 NW 3rd Avenue, asked if the settlement prohibits the City from conducting prayer breakfasts, recognizing the National Day of Prayer, or issuing a prayer proclamation. Mr. Sexton responded the settlement agreement does not contain prohibitions against future lawful conduct by the City.

Mr. Guinn spoke on the Freedom of Religion Group's demands to the City to remove religious words from the government logo. He discussed how the Kennedy case

(demonstrates legal standing) is directly related to the litigation matter before City Council. He anticipates the City will win the case if the matter goes before the Supreme Court; the City has an opportunity to defend the United States Constitution.

Rock Gibboney, 597 NE 45th Terrace, concurs with Mr. Guinn. He encouraged City Council to not settle.

Fernando Fernandez, 5725 Eco Road, spoke in support of freedom of religion.

Council Member Musleh expressed concern proceeding forward with the lawsuit, stating he is not willing to gamble with taxpayers' money. He suggested City Council consider the proposed settlement.

David Boston, 155 NE 52nd Avenue, spoke in opposition of the executed Memorandum of Understanding between the Ocala Police Department (OPD) and U.S. Immigration and Customs Enforcement (ICE). He expressed concern the partnership fuels a political narrative that instills fear in the community. He requested City Council terminate the agreement.

- Maryann Lambert, 13010 NW 90th Avenue, Reddick, FL, spoke on the OPD/ICE MOU

Maryann Lambert, 13010 NW 90th Avenue, Reddick, FL, spoke in opposition of the

executed Memorandum of understanding between the Ocala Police Department (OPD) and U.S. Immigration and Customs Enforcement (ICE). She expressed concern that the agreement violates illegal aliens' rights to due process. She questioned how the agreement is considered legal in the City of Ocala.

- Elizabeth Dollinger, 8500 NW 162nd Court, Morrison, FL, spoke on the OPD/ICE MOU

Diane Irwin, 4490 SW 44th Street, noted item 10(i) was not removed from the General Business section. She suggested the City allow vendors to perform a demo before making a final decision.

- Sandra Fernandez, 3270 NE 42nd Place, spoke on the OPD/ICE MOU

Sandra Fernandez, 3270 NE 42nd Place, spoke in opposition of the executed Memorandum of understanding between the Ocala Police Department (OPD) and U.S. Immigration and Customs Enforcement (ICE). She accused the Chief of Police Mike Balken of not sending help to Police Officers on January 6, 2025 and exonerating 1,500 insurrectionists. She believes the Chief of Police does not have the best interest of the public.

Police Chief Mike Balken spoke on the history of the Memorandum of understanding between the Ocala Police Department (OPD) and U.S. Immigration and Customs Enforcement (ICE). He stated OPD will not be raiding job sites or schools. The Police Officers will act on criminal acts committed in the City; illegal criminal aliens will be transferred to ICE custody. Furthermore, the department does not have the authority to deport illegal aliens. He recognized the department's efforts to arrest Tren de Aragua gang members.

Council Member Hilty stated Chief Balken is operating in the best interest of the public.

Council Members Bethea and Musleh, thanked Mr. Balken for clarifying the Memorandum of understanding between the Ocala Police Department (OPD) and U.S. Immigration and Customs Enforcement (ICE).

Police Chief Mike Balken noted the City can terminate the agreement at anytime by written intent.
