## AMENDMENT TWO PROFESSIONAL SERVICES AGREEMENT BETWEEN CITY OF DUNNELLON AND M.T. CAUSLEY, LLC



Amendment Two to the Professional Services Agreement effective November 2, 2020, between the City of Dunnellon, a Florida municipal corporation ("Municipality") and M.T. Causley, LLC, ("Consultant"). Municipality and Consultant shall be jointly referred to as the "Parties".

This Amendment shall be effective on January 1, 2023.

## **RECITALS AND REPRESENTATIONS**

WHEREAS, Municipality and Consultant entered into a Professional Services Agreement ("Agreement"), by which both Parties established the terms and conditions for service delivery for the period of November 2, 2020 through November 1, 2022; and

WHEREAS, Amendment One was executed October 24, 2022 with the purpose of adding services beyond those stipulated in the Agreement on an as-needed basis; and

WHEREAS, the Agreement allows for hourly rates to be increased based upon the annual increase in the Department of Labor, Bureau of Labor Statistics.

**NOW, THEREFORE,** in consideration of the mutual promises and covenants herein contained, and other good and valuable consideration, the receipt and adequacy of which are acknowledged, the Parties agree as follows:

- 1. The above recitals are acknowledged as true and correct and are incorporated herein.
- 2. Municipality to compensate Consultant based on Exhibit B Revised Fee Schedule for Services, hereto incorporated.
- 3. All other conditions and terms of the original Agreement and Amendment 1 not specifically amended herein, shall remain in full force and effect.
