- A. City and Tenant are parties to a Ground Lease at Airport (the "Original Lease") dated February 1, 2011.
- B. Tenant has requested that the premises identified in the Original Lease be changed, and that the Original Lease be otherwise amended as set forth herein.
- C. City has agreed to such matters pursuant to the terms and conditions hereof.

- Recitals. The recitals contained above are true, correct, and are incorporated herein by reference.
- Leased Premises. The Original Lease is amended to provide that Exhibit A thereto is replaced with the attached <u>Exhibit A</u>. Therefore, the attached <u>Exhibit A</u> now depicts the premises that are the subject of the Lease.

3. Rent.

- 3.1. Paragraph 3 of the Original Lease is amended as follows:
 - 3.1.1. The monthly rent (as set forth in paragraph 3.1.2 of the Original Lease) is, as of the Effective Date of this Amendment, \$1,339.63.
 - 3.1.2. Such monthly rent shall hereafter adjust as set forth in paragraph 3.1.3 of the Original Lease.
- 3.2. All other provisions of paragraph 3 of the Original Lease are not amended.
- 4. Effect on Original Lease. Except as expressly set forth herein, the Original Lease is not amended or modified. All references in the Original Lease or herein to "this Lease" or "this Agreement" shall be deemed to refer to the Original Lease as amended hereby.
