



FIRST AMENDMENT TO AGREEMENT FOR UNDERGROUND/AERIAL CABLE INSTALLATION – AS NEEDED

THIS FIRST AMENDMENT TO AGREEMENT FOR UNDERGROUND/AERIAL CABLE INSTALLATION – AS NEEDED ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **SERVICE AND TECHNOLOGY NETWORK SOLUTIONS, INC.**, a for-profit corporation duly organized in and authorized to do business in the state of Florida (EIN: 20-2532775) ("Contractor").

WHEREAS, on December 16, 2022, City and Contractor entered into an Agreement Underground/Aerial Cable Installation – As Needed (the "Original Agreement") for a term of two (2) years from December 7, 2022, to December 6, 2024; and

WHEREAS, City and Contractor now desire to extend the Original Agreement for the first of two one (1) year renewal terms available under the Original Agreement, and to adjust the pricing over the renewal term.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this First Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for a **ONE (1) YEAR** term beginning on **DECEMBER 7, 2024**, and terminating **DECEMBER 6, 2025**. Thereafter, this Agreement may be renewed for **ONE (1)** additional **ONE (1) YEAR** period by written consent between City and Contractor.
4. **AMENDMENT TO EXHIBIT B PRICE PROPOSAL.** The document attached to the Original Agreement as **Exhibit B – Price Proposal** is hereby deleted and replaced in its entirety with **Amended Exhibit B – Price Proposal**, attached hereto.
5. **COMPENSATION.** The highest total compensation payable to Contractor by City for the satisfactory performance of services in compliance with Exhibit A – Scope of Work and the Contract Documents shall be **TWO MILLION THREE HUNDRED THOUSAND AND NO/100 DOLLARS (\$2,300,000)** over the Renewal Term. Compensation paid to Contractor shall be paid in accordance with the pricing schedule set forth below:
6. **JESSICA LUNSFORD ACT.** Contractor may be required to perform services in conjunction with the City's contract for Fiber Services to Remote Schools with the School Board of Marion County. Consequently, employees or independent contractors of Contractor who will be tasked with performing said services shall be required to submit to a Level 2 FDLE background check and FBE screening, including fingerprinting within **SIXTY (60) DAYS** of contract execution. Neither Contractor nor its employees or independent contractors shall provide any services until the City is provided with notice of clearance and issues official School District badges for the employees or independent contractors of Contractor. All Contractor employees or independent contractors must register as a visitor before entering School Board property and properly display their School



District badges. Contractor agrees to indemnify and hold harmless the City, the School Board, and their respective officers, agents, and employees from any liability in the form of physical injury, death, or property damage resulting from Contractor's failure to comply with the requirements of this paragraph.

7. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the First Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original First Amendment for all purposes.
10. **LEGAL AUTHORITY.** Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
