



## SECOND AMENDMENT TO AGREEMENT FOR SOCCER MAINTENANCE

THIS SECOND AMENDMENT TO AGREEMENT FOR SOCCER MAINTENANCE ("Second Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **BIG SUN YOUTH SOCCER LEAGUE INC.**, a not-for-profit corporation ("Soccer").

**WHEREAS**, on March 18, 2008, City and Big Sun Youth Soccer League, Inc. entered into an Agreement (the "Original Agreement") for the City to provide maintenance services to the recreational facility and soccer fields; and

**WHEREAS**, on October 26, 2024, City and Big Sun Youth Soccer League, Inc. entered into a First Amendment (the "First Amendment") to amend the compensation amount specified in the Original Agreement; and

**WHEREAS**, City and Soccer now desire to modify the maintenance schedule as set forth in the Original Agreement, as amended in accordance with **Amended Exhibit A – Schedule "A."**

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Soccer agree as follows:

1. **RECITALS.** City and Soccer hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Soccer is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this Second Amendment.
3. **AMENDMENT TO EXHIBIT A – SCHEDULE "A".** The document attached to the Original Agreement, as amended, as **Exhibit A** is hereby deleted in its entirety and replaced with **Amended Exhibit A- Schedule "A"**.
4. **PUBLIC RECORDS.** Soccer shall comply with all applicable provisions of the Florida Public Records Act, Chapter 119, Florida Statutes. Specifically, Soccer shall:
  - A. Keep and maintain public records required by the public agency to perform the service.
  - B. Upon request from the public agency's custodian of public records, provide the public agency with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Chapter 119, Florida Statutes, or as otherwise provided by law.
  - C. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if Soccer does not transfer the records to the public agency.
  - D. Upon completion of the contract, transfer, at no cost, to the public agency all public records in possession of Soccer or keep and maintain public records required by the public agency to perform the service. If Soccer transfers all public records to the public agency upon completion of the contract, Soccer shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If Soccer keeps and maintains public records upon completion of the contract, Soccer shall meet all applicable requirements for retaining public records. All records stored electronically must be provided

to the public agency, upon request from the public agency's custodian of public records, in a format that is compatible with the information technology systems of the public agency.

5. **NOTICES.** All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Further, a duplicate or copy of the Second Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Second Amendment for all purposes.
8. **LEGAL AUTHORITY.** Each person signing this Second Amendment on behalf of either party





## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format.
