Approve a two-year contract with Grandview Landscaping Services, Inc. for street sweeping services with an expenditure of \$400,000

BACKGROUND:

The Public Works Stormwater Division is requesting approval of contract #PWD/240267 utilizing Grandview Landscaping Services, Inc. to provide street sweeping services for City-maintained curbed roads and parking lots. The contractor will sweep year-round on a set schedule but may also be called upon to provide services as the need arises for special events and emergencies. Street sweeping is desirable to keep roadways free of debris that accumulates and could cause a blockage in the stormwater drainage system.

FINDINGS AND CONCLUSIONS:

On January 12, 2024, Invitation to Bid (ITB) No.: PWD/240267 was released for the provision of two years of street sweeping services. Five bids were received with the following results:
