Re: Lake Louise Estates Development

My name is Betsy Roberts and my family and I own one of the houses in the Lake Louise Property, 520 SW 28th St.. I am in opposition to the proposed zoning change from Single Family Homes to a PUD with 312 apartment units.

The land on the Southwest side of Lake Louise has already been designated in the Florida Registry as a Native American Site. This is just from a historical perspective and there are many more issues to consider, starting with the increase of traffic on SW 7th Ave. as well as the entrance to the planned apartments. This could become more hazardous to anyone trying to enter or exit 7th Avenue from their residence. We are also concerned with possible problems with the wells in the area coming from the aquifer below. Our water quality will more than likely be negatively impacted from this development. Each unit of the proposed complex will have at least 1 to 4 people, possibly more living there and probably each having a car, this alone would have possible gas , oil and storm water runoff into the ground water. The attorneys for the development stated at one point during the meeting this summer that this apartment complex would be less impactful than single family homes. I disagree and would hope that you will take these issues into consideration when making your decision on re-zoning this beautiful area into a Planned Unit Development with 312 apartments. There is a better use for this property. Thank you.
