BACKGROUND:

The Ocala Police Department (OPD) began utilizing the Priority Dispatch system in 2016 which implements high standards for questions to be asked by call takers. This system was expanded to include all police, fire, and medical calls for service. The Priority Dispatch system greatly enhances the ability of call takers at OPD to obtain critical information quickly to disseminate to first responders which ultimately better assists citizens of the city and county.

FINDINGS AND CONCLUSIONS:

The Priority Dispatch system is highly consequential for public safety. The communications center utilizes this system on every call received, emergency or otherwise. Thus, call takers can quickly capture critical information to disseminate to first responders which ultimately provides safety and security for the public as well as those responding. Priority Dispatch is commonly utilized throughout the public safety industry. Renewing this contract will maintain all software updates and documentation required to run the Priority Dispatch system.

FISCAL IMPACT:

Funding for these purchases was approved as part of the Fiscal Year 2024-25 police department budget and \$86,700 is budgeted in expenditure account 001-018-811-521-52-52050. This purchase will be tracked by Munis contract number 250421.
