ARTWORK

BILLING

Corporate accounts that require payment to be made by check, will be due upon receipt of invoice.

DEFAULT

Upon default in the payment of the sums due hereunder, you will be required to provide another working card or company check within 10 days or 352 Preview may discontinue advertising, however, such discontinuance does not relieve Advertiser of the contract obligations. In the event a payment is not made within thirty (30) calendar days of its due date, a late charge of \$25 shall be due in addition to accruing interest of 1.5% per month.

FINANCE CHARGES

All payments in arrears shall bear interest at 1.5% per month and this interest rate shall accrue on any judgments entered based upon this contract.

CANCELLATION BY 352 PREVIEW

352 Preview reserves the right to cancel this Agreement for any reason at any time

CANCELLATION BY ADVERTISER

If Advertiser wishes to cancel a contract without running the remaining advertisement placements, the Advertiser will be billed the appropriate Short Rate. Advertiser may cancel his/her remaining advertising insertions in this agreement subject to its compliance with the following;

1. Advertiser provides 352 Preview with a written notice of cancellation specifying an effective date of cancellation no less than 30 days before the next insertion date, AND

2. Advertiser pays 352 Preview prior to the effective date of cancellation, any unpaid charges which are due up to the cancellation date PLUS a \$250 cancellation charge, any unpaid interest AND
3. Advertiser pays 352 Preview the appropriate Short Rate.

SHORT RATE

The short-rate (which is the difference between the rate charged on the contracted frequency and the higher rate based on the reduced frequency of advertisements actually published). A higher periodic rate will be charged to the advertiser, upon early cancellation of the advertising agreement, by either publisher or advertiser, and the rate will be determined by the current published 352 Preview rate card.

ATTORNEYS/COLLECTION AGENCY FEES

If Advertiser's account is delinquent and placed with an attorney or collection agency, Advertiser agrees to pay any attorney's fees or cost of collection or other expenses incurred in collection of monies due 352 Preview. Any court action or formal dispute resolution (arbitration or mediation) to occur in Marion County, Florida.
