Describing a specific Agreement between Kimley-Horn and Associates, Inc. Project: SW 43rd Court at SW 20th Street Signal – Construction Phase Services

General Category of Services:

Under a separate IPO, Kimley-Horn prepared structural plans for signal plans prepared by the City for the intersection of SW 43rd Court at SW 20th Street Signal. The City is currently under construction for the improvements at the intersection. The City has a Construction Engineering Inspection (CEI) consultant working on the project. The City has requested Kimley-Horn to provide engineer of record support during construction.

SCOPE OF SERVICES

Task 1 – Limited Construction Phase Services

A. Kimley-Horn will perform engineer of record services during the construction phase of the Project, as requested by the City. The services under this scope will be limited to:

- 2) Shop drawing review;
- 3) Field review;

Getting paper copies
