**FIRST AMENDMENT TO AGREEMENT KEYNOTE SPEECH – SKATE PARK GRAND RE-OPENING**

THIS FIRST AMENDMENT TO AGREEMENT FOR KEYNOTE SPEECH – SKATE PARK GRAND RE-OPENING ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), and **CAL ENTERTAINMENT, INC.** ("Agent") **F/S/O RODNEY MULLEN** ("Speaker").

**WHEREAS**, on January 16, 2026, City and Speaker entered into an Agreement for Keynote Speech – Skate Park Grand Re-opening (the "Original Agreement"), City of Ocala Contract Number: REC/260354; and

**WHEREAS**, after full execution of the Original Agreement the City and Agent now seek to add an additional appearance for a film screening event for an additional fee.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Agent agree as follows:

1. **RECITALS.** City and Agent hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Agent is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
3. **COMPENSATION.** City shall pay Agent an amount not to exceed **FOURTEEN THOUSAND FIVE HUNDRED, AND NO/100 DOLLARS (\$14,500)** (the "Contract Sum") as full and complete compensation for the timely and satisfactory performance of services. The pricing in this Agreement may only be adjusted by written amendment executed by both parties.
4. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

### **Withdrawing your consent**
