SECOND AMENDMENT TO AGREEMENT FOR ENVIRONMENTAL WATER TESTING SERVICES

THIS SECOND AMENDMENT TO AGREEMENT ENVIRONMENTAL WATER TESTING SERVICES ("Second Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **PACE ANALYTICAL SERVICES, LLC**, a limited liability company duly organized in the state of Minnesota and authorized to do business in the state of Florida (EIN# 41-1821617) ("Vendor").

WHEREAS, on October 26, 2021, City and Vendor entered into an Agreement for Environmental Water Testing (the "Original Agreement"), City of Ocala Contract Number: WRS/210139, for a term of three (3) years, from October 1, 2021, to September 30, 2024; and

WHEREAS, on November 7, 2023, City and Vendor entered into a First Amendment to Agreement to increase the total contract expenditure due to changes in federal and state testing requirements (the "First Amendment"); and

WHEARAS, City and Vendor now desire to extend the Original Agreement, as amended, for the first of two one-year renewal terms available under the Original Agreement and increase the pricing schedule by 3.3% for the Renewal Term.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

1. **RECITALS.** City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional (1) one-year term beginning on **OCTOBER 1, 2024** and terminating **SEPTEMBER 30, 2025**. Thereafter, this Agreement may be renewed for **ONE (1)** optional **ONE (1) YEAR** period by written consent between City and Vendor.
4. **COMPENSATION.** The highest total compensation payable to Vendor by City under this Second Amendment for the satisfactory performance of services in compliance with **Exhibit A – Scope of Work** and the Contract Documents shall be **NINETY THOUSAND AND NO/100 DOLLARS (\$90,000)** over the Renewal Term. Compensation paid to Vendor shall be paid in accordance with the pricing schedule set forth below:

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
