

## FIRST AMENDMENT TO AGREEMENT FOR AUTOMOTIVE AND TRUCK BODY REPAIR SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR AUTOMOTIVE AND TRUCK BODY REPAIR SERVICES ("First Amendment") is entered into by and between the <u>CITY OF OCALA</u>, a Florida municipal corporation ("City") and <u>MICHAEL LESSARD, INC., D/B/A PERFECTION COLLISION</u> <u>CARSTAR</u>, a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN: 20-196763) ("Vendor").

**WHEREAS**, on September 9, 2022, City and Vendor entered into an Agreement for Automotive and Truck Body Repair Services (the "Original Agreement"), City of Ocala Contract Number: FLT/220387 for a term of three (3) years from September 7, 2022, through September 6, 2025; and

**WHEREAS**, City and Vendor now desire to renew the Original Agreement for the first of two (2) additional one (1) year renewal periods available under the terms of the Original Agreement.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Vendor agree as follows:

- 1. **RECITALS**. City and Vendor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **RENEWAL TERM**. The Original Agreement is hereby renewed for an additional one (1) year term beginning **SEPTEMBER 7, 2025** and terminating **SEPTEMBER 6, 2026**. Thereafter, the parties acknowledge and agree that there remains the option for the Original Agreement to be renewed for up to **ONE (1)** additional **ONE (1) YEAR** period upon written agreement between the parties.
- 4. **COMPENSATION.** City shall pay Vendor an amount not to exceed **ONE HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$150,000)** over the one (1) year renewal term as full and complete compensation for the timely and satisfactory performance of services in accordance with the Contract Documents.
- 5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
