#### **BACKGROUND:**

On July 18, 2017, City Council approved a legislative management contract with Accela, Inc. (Accela) for MinuteTraq software including agendas and minutes management. In March of 2018, Granicus LLC (Granicus) purchased Accela and assumed the legislative management contract for our agenda services. The City transitioned from MinuteTraq to Legistar in 2022 for more robust legislative management and agenda services.

Granicus provides the Legistar software which produces the City's agenda and minutes for City Council, and its boards and commissions. This one-year software renewal for Legistar is from April 1, 2024, to March 31, 2025.

The software is used by numerous employees to enable the completion of agendas.

#### FINDINGS AND CONCLUSIONS:

Legistar software is used for the creation of the City Council agenda and minutes for the City of Ocala, and its boards and commissions. The software provides a central source for agenda creation and access throughout departments.

#### **FISCAL IMPACT:**

The software pricing increased 5 percent this year as stated in the original contract. Funds are budgeted in 001-012-212-512-51-52045 for six months from 4/1/24 through 9/30/24 for \$32,807. Funds are budgeted in 001-155-000-000-75-15500 for six months from 10/1/24 through 3/31/25 for \$32,807.
