Planning	On February 28, 2024 the City of Ocala and Terracon held an internal meeting with the Florida Department of Environmental Protection (FDEP) to discuss the current groundwater use restrictions at Reed Place, the FDEP provided feedback on how to address state regulatory requirements and assessment related to amending groundwater use for the proposed revitalization planning effort. Terracon provided a memorandum to the FDEP on April 7. 2025 for review and input which incorporates the proposed supplemental phase II work.

Programmatic Support	 The 2025 Quarter 1 Report was submitted to the EPA on January 28, 2025, via ACRES. The EPA approved this report on January 28, 2025. The City of Ocala, EPA and Terracon held a grant progress meeting on April 7, 2025, to discuss grant progress and updates from the EPA since the federal pause in January. One Brownfield Advisory Committee meeting was held on January 23, 2025.

As of March 2025, the CAR has drawn down and disbursed 67% of funds for eligible activities, procured two Qualified Environmental Professional, initiated or completed assessments on 15 sites, and conducted site inventory activities and completed two planning task.

The recipient has made sufficient progress; therefore, no corrective action has taken place.

The new review process requiring two EPA reviews of SSQAPPs are causing delays to complete Phase II work. A pause in federal funding and approvals of grant related tasks in January 2025 has also caused minor delays in communications and progress.

One ABCA and two Phase I ESAs have been completed this quarter, while the pending approval of the SSQAPP for the proposed Supplemental Phase II ESA is in progress and projected to be conducted next reporting period. The CAR is working with environmental consultants to finalize the Brownfields Revitalization Plan document, which has undergone two review cycles by the grant recipient. It is expected to be completed in the next quarter. The recipient is planning a final community outreach meeting to share highlights of the completed document

Budget and Overall Project Status

No modifications have been made to the original budget plan submitted in June 2022.

The EPA approved an increase of \$15,000 for the CAR's training budget item for the remainder of the grant period. The City intends to participate in the upcoming National Brownfields Training Conference in August

2025 and the Florida Brownfields Association conference in September 2025. Neither a work plan nor budget amendment is needed since the change is less than 10% of the total grant.

Grant planning and workplan is in process. No modifications have been made to the original workplan submitted in June 2022.
