

**FIRST AMENDMENT TO AGREEMENT FOR TRANSPORTATION REHABILITATION
IMPROVEMENT PROGRAM ("TRIP") PROJECTS**

THIS FIRST AMENDMENT TO AGREEMENT FOR TRANSPORTATION REHABILITATION IMPROVEMENT PROGRAM ("TRIP") PROJECTS ("First Amendment") is entered into by and between CITY OF OCALA, a Florida municipal corporation ("City"), and C.W. ROBERTS CONTRACTING, INC., a for-profit corporation duly organized in Indiana and authorized to do business in the State of Florida (EIN# 59-1683951) ("Contractor").

WHEREAS, on October 25, 2021, City and C.W. Roberts Contracting, Inc. entered into an Agreement for Transportation Rehabilitation Improvement ("TRIP") Projects (the "Original Agreement"), City of Ocala Contract Number: CIP/210785, for a term beginning September 29, 2021 and ending May 5, 2022; and

WHEREAS, City and Contractor now desire to modify the document attached to the Original Agreement as Exhibit B – Price Proposal to reflect additional services.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
3. **AMENDMENT TO EXHIBIT B – PRICE PROPOSAL.** The document attached to the Original Agreement as Exhibit B – Price Proposal is hereby deleted and replaced, in its entirety, with the document attached to this First Amendment as **Amended Exhibit B – Price Proposal**.
4. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:
