

SECOND AMENDMENT TO AGREEMENT FOR CITYWIDE PRESSURE WASHING SERVICES

THIS SECOND AMENDMENT TO AGREEMENT FOR CITYWIDE PRESSURE WASHING SERVICES ("Second Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), and **SHEPHARD HOME SERVICES**, **LLC**, a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 87-1832136) ("Contractor").

WHEREAS, on August 31, 2023, City and Contractor entered into an Agreement for Citywide Pressure Washing Services (the "Original Agreement"), City of Ocala Contract Number: COO/230389, for a term of two (2) years, from August 7, 2023 through August 6, 2025; and

WHEREAS, on October 2, 2024, City and Contractor entered into a First Amendment to Agreement for Citywide Pressure Washing Services ("First Amendment") to modify the total expenditure limit established under the terms of the Original Agreement; and

WHEREAS, City and Contractor now desire to renew the term of the Original Agreement, as amended, for the first of two (2) available one (1) year renewal periods available under the terms of the Original Agreement.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
- 3. **RENEWAL TERM**. The Original Agreement is hereby renewed for an additional one-year term beginning **AUGUST 7**, **2025** and terminating **AUGUST 6**, **2026**. Thereafter, the parties acknowledge and agree that there remains the option for the Original Agreement to be renewed for **ONE (1)** additional **ONE (1) YEAR** period upon written agreement between the parties.
- 4. COMPENSATION. City shall pay Contractor an amount not to exceed <u>FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000)</u> (the "Contract Sum") over the renewal term as full and complete compensation for the timely and satisfactory performance of services to the City in accordance with the Contract Documents. The pricing in this Agreement may only be adjusted by written amendment executed by both parties.
- 5. **NOTICES**. All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the Second Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Second Amendment for all purposes.
- 8. **LEGAL AUTHORITY**. Each person signing this Second Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
