

FIRST AMENDMENT TO AGREEMENT FOR WATER FEATURE MAINTENANCE SERVICES – M.O.M.S. PARK

THIS FIRST AMENDMENT TO AGREEMENT FOR WATER FEATURE MAINTENANCE SERVICES – M.O.M.S. PARK ("Agreement") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **TOUCH OF PARADISE DESIGNS, INC**, a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN: 20-2742393) ("Vendor").

WHEREAS, on March 14, 2022, City and Touch of Paradise Designs, Inc. entered into an Agreement for Water Feature Maintenance Services - M.O.M.S Park (the "Original Agreement"), City of Ocala Contract No.: REC/210627, for a term of three years from March 2, 2022, through March 1, 2025; and

WHEREAS, City and Vendor now desire to renew the Original Agreement for the first of two one-year renewals available under the Original Agreement.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Vendor agree as follows:

- 1. **RECITALS**. City and Vendor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement, between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except, for those terms and conditions expressly amended by this First Amendment.
- 3. **RENEWAL TERM.** The Original Agreement, as amended, is hereby renewed for an additional (1) one-year term beginning on <u>MARCH 2, 2025</u>, and terminating <u>MARCH 1, 2026</u>. Thereafter, this Agreement may be renewed for <u>ONE (1)</u> additional <u>ONE (1)</u> YEAR period by written consent between City and Vendor.
- 4. RENEWAL COMPENSATION. Vendor shall be paid a price not to exceed the maximum limiting amount of <u>ELEVEN THOUSAND</u>, <u>AND 00/100 DOLLARS (\$11,000)</u> (the "Contract Sum") over the Renewal Term as full and complete compensation for the timely and satisfactory provision of maintenance services for water features located at M.O.M.S. Park, 3320 SE 17th Street, Ocala, Florida 34471.
- 5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

- 8. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. Withdrawing your consent
