

FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG ASBESTOS, MOLD, AND LEAD-BASED PAINT INSPECTION SERVICES – AS NEEDED

THIS FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG ASBESTOS, MOLD, AND LEAD-BASED PAINT INSPECTION SERVICES – AS NEEDED ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **PB03 ENVIRONMENTAL MONITORING, LLC.** a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 81-1982807) ("Contractor").

WHEREAS, on October 30, 2023, City and Contractor entered into an Agreement for SHIP/HOME/CDBG Asbestos, Mold and Lead- Based Paint Inspection Services – As Needed (the "Original Agreement"), City of Ocala Contract No.: CDS/230727, for a term of two (2) years starting from October 18, 2023, through October 17, 2025; and

WHEREAS, City and Contractor now desire to renew the Original Agreement for the sole available one (1) year term.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

- 1. **RECITALS**. City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **COMPENSATION.** City shall pay Contractor a price not to exceed **FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000)** (the "Contract Sum") as full and complete compensation for the timely and satisfactory provision of services over the Renewal Term.
- 4. **RENEWAL TERM.** The Original Agreement, as amended, is hereby renewed for a one-year term beginning on <u>OCTOBER 18, 2025,</u> and terminating <u>OCTOBER 17, 2026</u>.
- 5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
