Dear Bill,

As you know, the subject contract expires on September 30, 2025. The initial contract term was for two years. The contract has two one-year renewals remaining. The purpose of this letter is to indicate Odyssey Manufacturing Co.'s desire to renew the subject contract with a price increase from \$1.75 to \$1.79 which represents an increase of 2.3%.

As you know, the cost of business continues to go up each year between labor, utilities, raw materials and energy. Over the past two years of service, our cost increases have pretty much mirrored inflation, which has been running around 2.0% - 3.5% annually. The only exception to this is our property and liability insurance. which went up over \$2.5 million over the two years, which equates to an increase of about \$.04 per gallon all by itself based on our annual sales volume.

The contract allows for price increases at the renewal period which "shall not exceed the lesser of: (i) the amount of percentage increase reflected by the Consumer Price Index for all Urban Consumers (CPI-U) not seasonally adjusted based on the most recent TWELVE (12) MONTH period; or (ii) THREE PERCENT (3%) ANNUALLY unless there are mitigating market conditions." Enclosure (1) demonstrates that the CPI-U referenced above went up 2.3% over the past twelve months. As such, Odyssey's requested increase mirrors the lesser of 2.3% and 3.0%.


