9a. Adopt Resolution 2025-9 to amend the Florida Professional Park (formerly known as Shady Road) Planned Unit Development, to amend a note prohibiting parking in the front yard along SW 34th Street Road (also known as SW 24th Avenue) relating to a 2.78-acre property located northwest of intersection at SW 32nd Place and SW 24th Avenue (Case No. PH24-0001) (Quasi-Judicial)

Council President Dreyer opened the public hearing.

Senior Planner Endira Madraveren discussed the adoption of Resolution 2025-9. The applicant requested to amend a note prohibiting parking in the front yard. She reviewed the property's history and noted a 17-foot slope on the existing topography creates a challenge to abide by the parking restriction. The applicant is requesting an exception to Lots 3, 4 and 5 within Block A. The Planning & Zoning Commission and staff recommend approval.

Doug Iannarelli, Moorhead Engineering, stated he is speaking on behalf of the applicant, and agrees with the City's recommendation for approval.

#### - Drone show update

City Manager Pete Lee reported the City will present a recommendation at a future City Council meeting. Mr. Lee noted Sky Elements has not yet been paid.

#### 13. Ocala Police Department Report

#### - Police Department Year in Review

Police Chief Mike Balken presented the Police Departments efforts for year 2024. Year-to-date, dispatch calls for service 65,640, self-initiated calls 102,554, homicides 5, traffic fatalities 14, traffic crashes 3,665, Baker Acts 683.

#### - Overview of Crime and Traffic Stops

Police Chief Mike Balken provided a brief overview of the department's efforts regarding crime and traffic stops. He noted crime activity was more active on the west side of Ocala over this period; however, it tends to fluctuate. The department has conducted 832 traffic stops during a four-week period.

#### - Berkeley Pointe update

Police Chief Mike Balken reported on community policing efforts. The department conducted a pilot program at the Berkeley Pointe apartment complex. The data shows the calls for service dropped for year 2024 compared to year 2023.

#### 14. Ocala Fire Rescue Department Report

#### - Ocala Fire Rescue update

Fire Chief Clint Welborn presented the unit responses data for December 22, 2024 to January 5, 2025.

#### - Unit Responses

Fire Chief Clint Welborn reported Fire Rescue Three had the most unit responses during the two-week period. The addition of Fire Rescue Six has helped reduce the call load for Fire Rescue Four.

#### - Call Type Spotlights

Fire Chief Clint Welborn reported on call type spotlights: motor vehicle accidents 51, structure fires 4, and community paramedicine/core 40. The department received 857 calls for service from December 22, 2024 to January 5, 2025, and 339 calls for service from January 1, 2025 to January 6, 2025.

#### - Department Highlights

Fire Chief Clint Welborn reported for the year, the department received 25,000 calls and 14,000 public education contacts. The department had several retirements and promotions last year. The highlight of the New Year, the department had a successful baby delivery on January 2, 2025.

Council President Dreyer shared her wonderful experience at Fire Rescue Three.

#### 15. City Attorney's Report

#### - Attorney-client shade meeting scheduled for January 21, 2025, at 3:15 pm

City Attorney Sexton reported the attorney-client shade meeting is scheduled for January 21, 2025. The meeting is regarding negotiations for the pending litigation regarding case #2412634, Rojas v. City of Ocala.

#### 16. Public Comments

#### - Manny Camps commented on actions by Ocala Police Officers

Manny Camps expressed concern regarding the Ocala Police Department's actions for harassment and his arrest. He requested to meet with Mayor Marciano to discuss the urgent matter. He submitted a letter and copy of a public records request email to City Council.

#### - Rock Gibboney commented on human trafficking prevention

Rock Gibboney spoke on human trafficking prevention efforts. He stated 800,000 people are considered missing annually. Laws enacted during Donald Trump's presidency, to support human trafficking prevention efforts, have resulted in many executive resignations in the United States and helped with efforts in Saudi Arabia. Currently, over 23 million undocumented illegal immigrants have crossed into the United States; a public safety concern.
