

#### FIRST AMENDMENT TO AGREEMENT FOR SOCCER MAINTENANCE

THIS FIRST AMENDMENT TO AGREEMENT FOR SOCCER MAINTENANCE ("First Amendment") is entered into by and between <u>CITY OF OCALA</u>, a Florida municipal corporation ("City"), and <u>BIG SUN YOUTH SOCCER LEAGUE INC.</u>, a not-for-profit corporation ("Soccer").

**WHEREAS**, on March 18, 2008, City and Big Sun Youth Soccer League, Inc. entered into an Agreement for the City to provide maintenance services to the recreational facility and soccer fields; and

**WHEREAS**, City and Big Sun Youth Soccer League, Inc. now desire to amend the compensation amount specified in the Original Agreement.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Soccer agree as follows:

- 1. **RECITALS.** City and Soccer hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Soccer is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this First Amendment.
- 3. **AMENDMENT TO SECTION 2 COMPENSATION**. The language contained in Paragraph 2-Compensation is hereby deleted in its entirety and replaced with the following:
  - **COMPENSATION**. Soccer will pay City **SEVENTEEN THOUSAND, TWO HUNDRED EIGHTY AND NO/100 DOLLARS (\$17,280)** (the "Contract Sum") per year payable in four (4) quarterly installments in the amount of **FOUR THOUSAND, THREE HUNDRED TWENTY AND NO/100 DOLLARS (\$4,320)**. Additional services for maintenance, not otherwise addressed herein, shall be invoiced by the City at the direct cost to provide same.
- 4. **PUBLIC RECORDS.** Soccer shall comply with all applicable provisions of the Florida Public Records Act, Chapter 119, Florida Statutes. Specifically, Soccer shall:
  - A. Keep and maintain public records required by the public agency to perform the service.
  - B. Upon request from the public agency's custodian of public records, provide the public agency with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Chapter 119, Florida Statutes, or as otherwise provided by law.
  - C. Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the contract term and following completion of the contract if Soccer does not transfer the records to the public agency.
  - D. Upon completion of the contract, transfer, at no cost, to the public agency all public records in possession of Soccer or keep and maintain public records required by the public agency to perform the service. If Soccer transfers all public records to the public agency upon completion of the contract, Soccer shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If Soccer keeps and maintains public records upon completion of the contract, Soccer shall meet all applicable

requirements for retaining public records. All records stored electronically must be provided to the public agency, upon request from the public agency's custodian of public records, in a format that is compatible with the information technology systems of the public agency.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. # **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us.
