

FIRST AMENDMENT TO AGREEMENT FOR GRAPHIC WRAPPING OF THREE CITY SANITATION VEHICLES

THIS FIRST AMENDMENT TO AGREEMENT FOR GRAPHIC WRAPPING OF THREE CITY SANITATION VEHICLES ("First Amendment") is entered into by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **LOCO GRAPHICS**, **INC.**, a for-profit corporation duly organized and authorized to do business in the State of Florida (EIN# 46-1740759) ("Vendor").

WHEREAS, on February 16, 2022, City and Vendor entered into an Agreement for Graphic Wrapping of Three City Sanitation Vehicles (the "Original Agreement"), City of Ocala Contract Number: PWD/220017 for a term of two (2) years, from January 6, 2021, to January 5, 2022; and

WHEREAS, after the execution of the Original Agreement, it was discovered by the Parties that there was a scrivener's error in Paragraph 5(A) with respect to the effective date and term; and

WHEREAS, the Parties now desire to enter into this First Amendment to correct the scrivener's error.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

- 1. **RECITALS.** City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **AMENDMENT TO PARAGRAPH 5(A).** Paragraph 5(A) in the Original Agreement is hereby deleted and replaced in its entirety with the following:
 - **Effective Date and Term**. This Agreement shall become effective and commence on **JANUARY 6, 2022** and continue for a term of **ONE (1)** year, through and including **JANUARY 5, 2023**. This Agreement may only be renewed upon written consent between City and Vendor.
- 4. **NOTICES**. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail,





postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

- 6. **ELECTRONIC SIGNATURE(S).** Vendor, if and by offering an electronic signature in any form whatsoever, will accept and agree to be bound by said electronic signature to all terms and conditions of this First Amendment. Further, a duplicate or copy of the First Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original First Amendment for all purposes.
- 7. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
