



FOURTH AMENDMENT TO AGREEMENT FOR SALE OF SCRAP METAL – CITYWIDE

THIS FOURTH AMENDMENT TO AGREEMENT FOR SALE OF SCRAP METAL – CITYWIDE (“Fourth Amendment”) is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation (“City”) and **TRADEMARK METALS RECYCLING, LLC**, a limited liability company duly organized and authorized to do business in the state of Florida (EIN: 59-348760) (“Vendor” or “Receiver”).

WHEREAS, on November 3, 2021, City and Vendor entered into an Agreement for Sale of Scrap Metal – Citywide (the “Original Agreement”), City of Ocala Contract Number: COO/210916, for a term of three (3) years, from October 1, 2021, through September 30, 2024; and

WHEREAS, on August 16, 2022, City and Vendor entered into a First Amendment to Agreement for Sale of Scrap Metal – Citywide (the “First Amendment”) to modify the compensation terms from the Original Agreement and update the pricing for Iron and Steel; and

WHEREAS, on August 20, 2025, City and Vendor entered into a Second Amendment to Agreement for Sale of Scrap Metal – Citywide (the “Second Amendment”) to renew the Original Agreement, as amended, for an additional one (1) year term from October 1, 2024, through September 30, 2025; and

WHEREAS, on October 23, 2025, City and Vendor entered into a Third Amendment to Agreement for Sale of Scrap Metal – Citywide (the “Third Amendment”) to renew the Original Agreement, as amended, for an additional one (1) year term from October 1, 2025, through September 30, 2026; and

WHEREAS, City and Vendor now desire to further amend the Original Agreement, as amended, to revise the Compensation section to include an additional line item for electric meter recycling.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Vendor agree as follows:

1. **RECITALS.** City and Vendor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Vendor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Fourth Amendment.
3. **COMPENSATION.** Vendor shall purchase recyclable electric meters from the City at a rate of Seventy Cents (\$0.70) per pound. This rate reflects the fair market value as of the effective date of this Fourth Amendment. All price adjustments shall be commercially reasonable and consistent with fair market pricing standards. The pricing in this Agreement may only be adjusted by written amendment executed by both parties.

Further, a duplicate or copy of the Fourth Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Fourth Amendment for all purposes.
- 7. **LEGAL AUTHORITY.** Each person signing this Fourth Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Fourth Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Fourth Amendment.

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to contracts@ocalafl.org and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

- i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;
- ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
