Award Executive Summary: 2021 American Rescue Plan Grant Section 5307

Purpose: The purpose of this award is to provide partial funding for 1 year of operating assistance through capital cost of contracting to SunTran / City of Ocala to assist it in recovering from COVID-19, purchase bus equipment to mitigate the spread of COVID-19, and to fund a necessary update to the Transit Development Plan.

Activities to be performed: Funds will be used to cover all eligible operating expenses via capital cost of contracting such as driver salaries, fuel, items having a useful life of less than one year, etc. in order to continue transit operations. Funds will also be used for bus equipment to mitigate the spread of COVID-19 and planning work to update the Transit Development Plan.

Expected outcomes: Funding will permit SunTran to continue to provide operations during the COVID-19 pandemic.

Intended beneficiaries: SunTran and the riders that rely on its service will benefit from continued services, permitting workers to get to work and riders to get to essential services safely.

Subrecipient activities: None.

This is an FY2021 Section 5307 American Rescue Plan application in the full apportionment amount of \$627,007.00. Per the ARP, the grant request is for 100% federal share. The application scope of work includes capital and operating expenses for the provision of SunTran service. Operating funds will cover expenses for existing service through capital cost of contracting, including contract costs for operation of the buses through the City of Ocala's Type 1 Service Contract with RATP Dev, and the capital cost of contracting. The operational assistance expenses requested in this application were determined by reviewing NTD data, our Type 1 Service Contract with RATP Dev, and invoices or other records of payments for SunTran expenses organized by the Department's Fiscal Manager. The City of Ocala understands that the expenses requested in this application are subject to review for their reasonableness as part of the

agency's next Triennial/State management review.

The Recipient (City of Ocala) certifies that it, and its subrecipients and contractors that are providers of public transportation, have not furloughed any employees since March 27, 2020 (the enactment date of the CARES Act).

The Recipient agrees that if it receives Federal funding from the Federal Emergency Management Agency (FEMA) or through a pass-through entity through the Robert T. Stafford Disaster Relief and Emergency Assistance Act, a different Federal agency, or insurance proceeds for any portion of a project activity approved for FTA funding under this Grant Agreement, it will provide written notification to FTA, and reimburse FTA for any Federal share that duplicates funding provided by FEMA, another Federal agency, or an insurance company.

The Governor's Apportionment letter, dated April 23, 2021, is attached to this application.

The current Ocala/Marion County TPO Unified Planning Work Program Public Transportation section (pages 25-28) is attached to this application and includes the City's responsibility to update the Transit Development Plan.

The City of Ocala is using ALI 11.42.09 to satisfy the 1% security requirement.

Per ARP, the project in this application is not required to be programmed in the Long-Range Transportation Plan, Statewide Transportation Plan, or Statewide Transportation Improvement Program.

The City of Ocala receives ARP Act funds through FDOT, in accordance with FTA procedures for urbanized areas with populations below 200,000. There are no matching funds associated with this ARP Act grant. The City of Ocala will follow all 3rd party procurement policies as defined in C4220.1F (Third Party Contracting Guidance). The City of Ocala will ensure contractors procured will not be on the FTA Suspension and Debarment list. The budget for this grant includes an FTA allocation of \$627,007.
