

**FIRST AMENDMENT TO COOPERATIVE PURCHASING AGREEMENT FOR CONTINUING  
PAVEMENT MANAGEMENT SERVICES**

THIS FIRST AMENDMENT TO COOPERATIVE PURCHASING AGREEMENT FOR CONTINUING PAVEMENT MANAGEMENT SERVICES ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **PAVEMENT TECHNOLOGY, INC.**, a foreign for-profit corporation duly organized in the state of Ohio and authorized to do business in the state of Florida (EIN: 34-1108308) ("Contractor").

**WHEREAS**, on January 7, 2025, City and Contractor entered into a Cooperative Purchasing Agreement for Continuing Pavement Management Services (the "Original Agreement"), City of Ocala Contract No.: CIP/250042, for a term beginning November 20, 2024, and ending September 30, 2025; and

**WHEREAS**, City and Contractor wish to renew the Original Agreement for a two (2) year term.

**NOW THEREFORE**, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except, for those terms and conditions expressly amended by this First Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional two (2) year term beginning on **OCTOBER 1, 2025**, and terminating **SEPTEMBER 30, 2027**, in accordance with the terms and conditions described in **Exhibit C – Gainesville Renewal**.
4. **COMPENSATION.** City shall pay Contractor a price not to exceed **ONE MILLION AND NO/100 DOLLARS (\$1,000,000)** (the "Contract Sum") over the Renewal Term as full and complete compensation for the timely and satisfactory provision of services in accordance with the pricing described in **Exhibit D – Renewal Offer Letter**.
5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

Further, a duplicate or copy of the First Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original First Amendment for all purposes.
8. **LEGAL AUTHORITY.** Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

SECOND AMENDMENT TO CONTINUING SERVICES AGREEMENT FOR PAVEMENT MANAGEMENT

THIS SECOND AMENDMENT ("Second Amendment") is entered into and enforceable as of the last signature date affixed hereto ("Effective Date") by and between the CITY OF GAINESVILLE, FLORIDA, a municipal corporation ("City"), and PAVEMENT TECHNOLOGY, INC., an Ohio corporation registered to do business in Florida ("Contractor"), individually referred to as "Party" or collectively as "Parties."

WHEREAS, the City and Contractor entered into a Continuing Services Agreement for Pavement Management dated May 8, 2023; and First Amendment dated August 8, 2023; and

WHEREAS, the City and Contractor desire to amend the Agreement.

NOW, THEREFORE, the Parties agree as follows:

- 1. The Agreement is hereby amended to extend the term through September 30, 2027.
2. Paragraph 3.3 Living Wage Requirements are not applicable, as provided in Section 255.0992, Florida Statutes and will hereby be removed.
3. Paragraph 3.3 Living Wage, will hereby be replaced with the following clause:
3.3 ANTI-HUMAN TRAFFICKING. On or before the Effective Date of this Contract and, in addition, on or before the effective date of each renewal or extension of this Contract, the Contractor shall provide the City with an affidavit, pursuant to Section 787.06(13), Fla. Stat., which is signed by an officer or a representative of the Contractor under penalty of perjury attesting that the Contractor does not use coercion for labor or services as those terms are defined in Section 787.06(13), Fla. Stat.
4. Paragraph 3.4 Apprentice and Disadvantage Worker Requirements are not applicable, as provided in Section 255.0992, Florida Statutes and will hereby be removed.
5. Exhibit 1 to the Original Agreement is hereby replaced with Exhibit 1 to this Amendment to reflect updated fee schedule.
6. Except as modified by this Second Amendment, all terms and conditions of the Agreement shall remain in full force and effect.
7. This Second Amendment and First Amendment together with the Original Agreement, constitutes the entire Agreement between Parties.
