

**FIRST RENEWAL OF AGREEMENT FOR
TRAFFIC SIGNAL AND STREET LIGHT PAINTING SERVICES**

THIS FIRST RENEWAL OF AGREEMENT FOR TRAFFIC SIGNAL AND STREET LIGHT PAINTING SERVICES, made and entered into on Mar 20, 2026 by and between the CITY OF SARASOTA, FLORIDA, a municipal corporation, hereinafter referred to as “CITY,” and BRETT M. MUSCAT D/B/A MUSCAT PAINTING & DECORATING, hereinafter referred to as “CONTRACTOR” (collectively the “Parties”).

W I T N E S S E T H :

WHEREAS, on March 22, 2023, CITY and CONTRACTOR entered into a three-year Agreement for Traffic Signal and Street Light Painting Services, outlining the terms by which CONTRACTOR will provide complete service to clean, prime, and paint various types of traffic signal and street light equipment at various locations throughout the CITY, pursuant to Invitation to Bid No. 23-11JS and as further defined in the Exhibit A Project Scope of Services attached to the original Agreement (hereinafter “Agreement”);

WHEREAS, the Agreement, by its terms, expires on March 21, 2026, but provides for up to two (2) additional one-year renewal periods, upon mutual agreement of the parties;

WHEREAS, CITY and CONTRACTOR desire to enter into this First Renewal of Agreement for Traffic Signal and Street Light Painting Services to extend the term of the Agreement for the first of two available one-year renewals (“First Renewal”);

WHEREAS, the First Renewal will commence on March 22, 2026 (the “Effective Date”) and expire on March 21, 2027;

WHEREAS, the First Renewal will renew at the prices set forth in Exhibit B to the original Agreement; and

WHEREAS, the City Manager is authorized to administratively approve and execute this First Renewal of Agreement on behalf of CITY, so long as there is no increase in the cost or fees to be paid by CITY.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. Section 4. Term is hereby amended to extend the term for the first of two additional one-year renewal periods, as follows:

The three-year term of the Agreement commenced on March 22, 2023 and will expire at 11:59 p.m. on March 21, 2026. This Agreement may be renewed for up to two additional one-year periods upon the mutual agreement of the parties. The First Renewal of Agreement will commence

on March 22, 2026 and expire on March 21, 2027. The prices set forth in Exhibit B to the original Agreement shall apply during the First Renewal term. The City Manager is hereby authorized to administratively approve and execute any of these Agreement extensions so long as there is no increase in the cost or fees to be paid by CITY.

2. Notwithstanding the actual date(s) of execution by the Parties, the Effective Date of this First Renewal of Agreement shall be the Effective Date provided for herein.

3. Except as expressly set forth herein, all of the terms, covenants, and conditions of the Agreement are hereby ratified and confirmed by CITY and CONTRACTOR and each, by the execution of this First Renewal of Agreement, hereby signifies their intent to be bound thereby.


