

**FIRST AMENDMENT TO AGREEMENT FOR LITTER CONTROL SERVICES**

THIS FIRST AMENDMENT TO AGREEMENT FOR LITTER CONTROL SERVICES ("First Amendment") is entered into this \_\_\_\_ day of \_\_\_\_\_, 2020, by and between **CITY OF OCALA**, a Florida municipal corporation ("City"), and **WEAR GLOVES, INC.**, a not-for-profit corporation duly organized and authorized to do business in the State of Florida (EIN# 27-3644705) ("Litter Control Provider").

**WHEREAS**, on September 6, 2019, City and Litter Control Provider entered into an Agreement for Litter Control Services (the "Original Agreement"), City of Ocala Contract Number: CMO/190357; and

**WHEREAS**, the term of the Original Agreement commenced on August 6, 2019 and is set to expire on July 31, 2020; and

**WHEREAS**, City and Litter Control Provider desire to extend the Original Agreement, as written, for the first of two additional one-year renewal periods available under the Original Agreement.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Litter Control Provider agree as follows:

1. **RECITALS.** City and Litter Control Provider hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Litter Control Provider is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional one-year term beginning **AUGUST 1, 2020** and terminating **JULY 31, 2021**. Thereafter, the parties acknowledge and agree that there remains the option for the Original Agreement to be renewed for one (1) additional one-year (1-year) period upon written agreement between the parties.

4. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:


