The department is approved to piggyback the contract awarded to R&M Service Solutions by the City of Tarpon Sprints, Contract No. 240055-B-AS, for the provision of small to mid-sized underground utility projects using a work order process through May 6, 2027. These services were competitively solicited by City of Tarpon Springs under RFP No. 240055-B-AS. Four vendors responded to the solicitation and awards were issued to all four vendors, to incude R&M Service Solutions. The award was for a three year contract from May 7, 2024 through May 6, 2027 and offers one two-year renewal term. R&M Service Solutions has agreed to extend pricing and services to the City of Ocala under the same terms and conditions as Contract No. 240055-B-AS.
