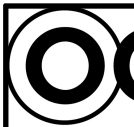

FINAL ADMINISTRATIVE ORDER

THIS CAUSE, came for public hearing before the Municipal Code Enforcement Board on; November 13th, 2025, after due notice to the Respondent(s), and the Municipal Code Enforcement Board having heard testimony under oath, received evidence, considered stipulations, and heard argument, thereupon issues its Final Administrative Order, Findings of Fact, Conclusion of Law, and Notice of Hearing on Compliance, and Imposition of Fines as follows:

I. FINDINGS OF FACT:

- A. The Respondent(s), **BAKER CONSTRUCTION & MANAGEMMNT LLC, 7 E. SILVER SPRINGS BLVD, STE 101, OCALA, FL 34470**, owner(s) in charge of the property described as: **1800 BLK N MAGNOLIA AVE | 25405-000-00, Ocala, Florida** recorded in the Public Records of Marion County, Florida.
- B. That on and between May 17th, 2023, and November 6th, 2025, the property, as described above, was in violation of the City of Ocala Code of Ordinances, **SECTION 118-71 TREE REMOVAL PERMIT REQUIRED; EXCEPTIONS, SECTION 122-212 SITE PLAN APPROVAL REQUIRED.**

II. CONCLUSION OF LAW:

- A. The Respondent(s), **BAKER CONSTRUCTION & MANAGEMMNT LLC**, by reason of the foregoing are in violation of the Code of Ordinances of the City of Ocala, **SECTION 118-71 TREE REMOVAL PERMIT REQUIRED; EXCEPTIONS, SECTION 122-212 SITE PLAN APPROVAL REQUIRED**, in that the Respondent(s) have failed to remedy the violation(s) and is subject to the provisions of the Code of Ordinances of the City of Ocala, Florida, Sections 2-426 and 2-443.

III. ORDER:

- A. Find the Respondent(s) guilty of violating city code section(s): 118-71 and 122-212 and order to:

1.) Obtain tree removal permits for the unpermitted removal of trees by 4:00pm on Thursday, January 1st, 2026. Once the permit is obtained, the work shall be completed within 60 days after the issuance of the initial permit. If the Respondent(s) fail to comply by 7:00am on Friday, January 2nd, 2026, or if the permit issued is not inspected and finalized by the 61st day after permit issuance, there shall be a fine of \$250.00 per day thereafter that shall run in addition to any other fines until the violation has been abated.


2.) Obtain any required permits needed to bring the site into compliance with city ordinance section 122-212 and site plan application SPL23-45404 by 04:00pm on Thursday, January 1st, 2026. Once the permits are obtained, all site work shall be completed by a licensed contractor within 180 days after the issuance of the initial permits. If the Respondent(s) fail to comply by 07:00 am on Friday, January 2nd, 2026, or if the permits issued expire without a final inspection finding that the work complies with the city codes, or if the permit issued is not inspected and finalized by the 181st day after permit issuance, there shall be a fine of \$250.00 per day thereafter that shall run in addition to any other fines until the violation has been abated.

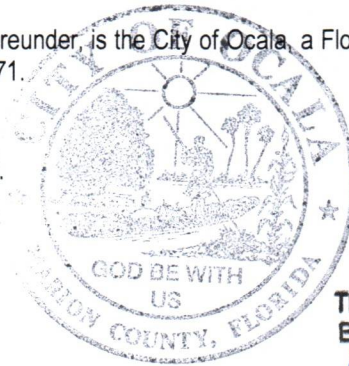

FINAL ADMINISTRATIVE ORDER

THIS CAUSE, came for public hearing before the Municipal Code Enforcement Board on; November 13th, 2025, after due notice to the Respondent(s), and the Municipal Code Enforcement Board having heard testimony under oath, received evidence, considered stipulations, and heard argument, thereupon issues its Final Administrative Order, Findings of Fact, Conclusion of Law, and Notice of Hearing on Compliance, and Imposition of Fines as follows:

FINDINGS OF FACT:

- A. The Respondent(s), **BAKER CONSTRUCTION & MANAGEMMNT LLC, 7 E. SILVER SPRINGS BLVD, STE 101, OCALA, FL 34470**, owner(s) in charge of the property described as: **1800 BLK N MAGNOLIA AVE | 25405-000-00, Ocala, Florida** recorded in the Public Records of Marion County, Florida.
- B. That on and between May 17th, 2023, and November 6th, 2025, the property, as described above, was in violation of the City of Ocala Code of Ordinances, **SECTION 118-71 TREE REMOVAL PERMIT REQUIRED; EXCEPTIONS, SECTION 122-212 SITE PLAN APPROVAL REQUIRED.**

II. CONCLUSION OF LAW:

- A. The Respondent(s), **BAKER CONSTRUCTION & MANAGEMMNT LLC**, by reason of the foregoing are in violation of the Code of Ordinances of the City of Ocala, **SECTION 118-71 TREE REMOVAL PERMIT REQUIRED; EXCEPTIONS, SECTION 122-212 SITE PLAN APPROVAL REQUIRED**, in that the Respondent(s) have failed to remedy the violation(s) and is subject to the provisions of the Code of Ordinances of the City of Ocala, Florida, Sections 2-426 and 2-443.

III. ORDER:

- A. Find the Respondent(s) guilty of violating city code section(s): 118-71 and 122-212 and order to:
- 1.) Obtain tree removal permits for the unpermitted removal of trees by 4:00pm on Thursday, January 1st, 2026. Once the permit is obtained, the work shall be completed within 60 days after the issuance of the initial permit. If the Respondent(s) fail to comply by 7:00am on Friday, January 2nd, 2026, or if the permit issued is not inspected and finalized by the 61st day after permit issuance, there shall be a fine of \$250.00 per day thereafter that shall run in addition to any other fines until the violation has been abated.
 - 2.) Obtain any required permits needed to bring the site into compliance with city ordinance section 122-212 and site plan application SPL23-45404 by 04:00pm on Thursday, January 1st, 2026. Once the permits are obtained, all site work shall be completed by a licensed contractor within 180 days after the issuance of the initial permits. If the Respondent(s) fail to comply by 07:00 am on Friday, January 2nd, 2026, or if the permits issued expire without a final inspection finding that the work complies with the city codes, or if the permit issued is not inspected and finalized by the 181st day after permit issuance, there shall be a fine of \$250.00 per day thereafter that shall run in addition to any other fines until the violation has been abated.

- 3.) Pay the cost of prosecution of \$439.19 by January 1st, 2026.



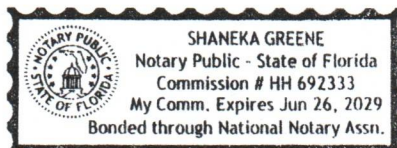

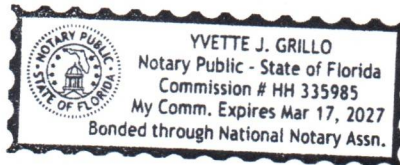
