

# SECOND AMENDMENT TO AGREEMENT FOR **GROUNDS MAINTENANCE SERIVES – CITY COMPLEX**

THIS SECOND AMENDMENT TO AGREEMENT FOR GROUND MAINTENANCE SERVICES - CITY COMPLEX ("Second Amendment") is entered into by and between CITY OF OCALA, a Florida municipal corporation ("City"), and SQUEEKIE KLEAN LANDSCAPING, LLC., a limited liability company duly organized and authorized to do business in the state of Florida (EIN# 27-2913828) ("Contractor").

WHEREAS, on September 15, 2021, City and Contractor entered into an Agreement for Grounds Maintenance Services - City Complex (the "Original Agreement"), City of Ocala Contract Number: PWD/210424 for a term of two (2) years, from August 22, 2021 to August 23, 2023; and

WHEREAS, On July 19, 2023, City and Contractor entered into a First Amendment to Agreement for Grounds Maintenance Services – City Complex (the "First Amendment") to extend the Original Agreement for the first of two available one-year renewals; and

WHEREAS, City and Contractor now desire to extend the Original Agreement, as amended, for the final one-year renewal term available under the Original Agreement.

**NOW THEREFORE**, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Second Amendment.
- 3. **RENEWAL TERM**. The Original Agreement is hereby renewed for an additional one-year term commencing AUGUST 23, 2024 and ending AUGUST 22, 2025.
- 4. **COMPENSATION.** Contractor shall be paid a price not to exceed the maximum limiting amount of THIRTY-SIX THOUSAND, AND NO/100 (\$36,000) (the "Contract Sum") over the Renewal Term as full and complete compensation for the timely and satisfactory performance of services.
- 5. **NOTICES**. All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. # **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

#### Withdrawing your consent

## To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
