

FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG ROOF REPLACEMENT

THIS FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG ROOF REPLACEMENT, ("First Amendment") is entered into by and between the **<u>CITY OF OCALA</u>**, a Florida municipal corporation ("City"), **<u>EVELYN REASON</u>** ("Owner"), and **<u>FLORIDA HOME CONTRACTORS, INC.</u>**, a forprofit corporation duly organized and authorized to do business in the state of Florida (EIN: 30-0463963) ("Contractor").

WHEREAS, on May 8, 2024, City, Owner, and Contractor entered into an Agreement for SHIP/HOME/CDBG roof replacement services on a residential property located at 720 NW 8th Street Ocala Florida 34475 (the "Original Agreement"), City of Ocala Contract No.: CDS/240569; and

WHEREAS, City, Owner, and Contractor now desire to amend the Original Agreement to reflect an increase in the Contract Price necessitated by the Work Change Directive issued May 21, 2024 and attached hereto as **Exhibit A – Work Change Directive**.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City, Owner and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City, Owner, and Contractor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- AMENDMENT TO PARAGRAPH 5 COMPENSATION. The language contained in Paragraph 5

 Compensation of the Original Agreement is hereby deleted and replaced with the following (all remaining sections of Paragraph 5 Compensation remain in effect):

COMPENSATION. City shall pay Contractor, on behalf of the Owner, for the performance of the work, and in accordance with the contract documents, a total price in the amount of **EIGHTEEN THOUSAND**, **FOUR HUNDRED EIGHTY-FOUR AND 66/100 DOLLARS (\$18,484.66)**. It is understood the amounts to be paid will be for satisfactory work completed rather than the estimated prices. Payments shall be made, at the unit price and/or lump sums specified for the various items in the Contractor's proposal as provided in the specifications.

- A. The modified Contract Price represents the sum of the original bid price of <u>\$15,740</u> and the total cost of <u>Change Order #1</u> as set forth in Exhibit A Work Change Directive.
- 4. NOTICES. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:

- 6. **ELECTRONIC SIGNATURE(S).** Contractor, if and by offering an electronic signature in any form whatsoever, will accept and agree to be bound by said electronic signature to all terms and conditions of this First Amendment. Further, a duplicate or copy of the First Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original First Amendment for all purposes.
- 7. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
