

Eligible Area	East Ocala CRA
Eligible Applicant	Property owner
Eligible Buildings	Contributing historic building or eligible to be contributing, built prior to 1922. Contributing buildings are buildings that have retained much of their historic architectural integrity
Eligible Property Type	Taxable & non-taxable properties; taxable properties are priority.
Ineligible Properties	Tax delinquent property; property in litigation; property in condemnation or receivership; property or tenants with outstanding financial obligations to City require City Council approval.
Eligible work	The purpose of the grant is for restoration and renovation of
Fixed build-out improvements include:	historic buildings. The buildings would also be eligible for other East Ocala Façade Grant programs.

	Only work begun <u>after</u> approval by the Ocala CRA (CRA) will be eligible for a grant. Work in progress or performed before approval will not be eligible.
Maximum Grant	\$25,000
Required Match	1:1; 50% - 50%
Design Guidelines	Subject to Historic Preservation Code and approval by Ocala Preservation Advisory Board as required.

Dear East Ocala CRA Property Owner:

You are receiving this letter because you own a historic building within the East Ocala CRA and may be eligible for a potential new building improvement grant. The East Ocala CRA Advisory Committee is considering expanding building improvement grant opportunities for historic properties. We are contacting historic property owners to understand what type of building improvements are needed and if any type of assistance may be needed.

Currently the East Ocala CRA has two building improvement grant programs that you may be able to utilize. If you own a residential property, there is a paint grant of up to \$2,000. If you own a commercial property, there is a commercial building grant for exterior improvement of up to \$10,000.

As restorations and renovations to historic properties are typically much more involved and costly, the CRA is considering expanding grant amounts for qualified historic properties. If you are interested in one of the current grant programs or the proposed grant program, please reply to CRA@ocalafl.org. Include your name, address, contact information, the type of improvements you are considering and the timeframe for your project. Please reply by February 22 so we can provide the information to the Committee at their meeting February 23 at 4:00 PM in the City Council Chambers –  $2^{nd}$  Floor City Hall.
