

FIRST AMENDMENT TO LEASE AND SERVICE AGREEMENT

THIS FIRST AMENDMENT TO LEASE AND SERVICE AGREEMENT ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **SAFE HAVEN BABY BOXES, INC.**, a foreign not-for-profit corporation duly organized in Indiana and authorized to do business in the state of Florida (EIN: 47-3038555) ("Provider").

WHEREAS, on April 21, 2021, City and Provider entered into a Lease and Service Agreement for the lease and provision of baby safety devices and related services (the "Original Agreement"), City of Ocala Contract Number: OFR/201069, for a term of five (5) years from November 6, 2020, through November 5, 2025; and

WHEREAS, City and Provider now desire to renew the Original Agreement for a five (5) year renewal period available under the terms of the Original Agreement.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Provider agree as follows:

- 1. **RECITALS**. City and Provider hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Provider is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional five (5) year term beginning **NOVEMBER 6, 2025**, and terminating **NOVEMBER 5, 2030**.
- 4. **COMPENSATION.** City shall pay Provider an amount not to exceed **TWO THOUSAND FOUR HUNDRED AND NO/100 (\$2,400)** (the "Contract Sum") over the renewal term as full and complete compensation for the timely and satisfactory provision of services in accordance with the terms of the Original Agreement.
- 5. **NOTICES.** All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by e-mail. All notices shall be addressed to the respective parties as follows:

- 8. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
