

THIRD AMENDMENT TO AGREEMENT FOR AIRPORT JANITORIAL SERVICES

THIS THIRD AMENDMENT TO AGREEMENT FOR AIRPORT JANITORIAL SERVICES ("Third Amendment") is entered into by and between the <u>CITY OF OCALA</u>, a Florida municipal corporation ("City"), and <u>HEAVENLY TOUCH CLEANING</u>, <u>LLC</u>, a limited liability company duly organized in and authorized to do business in the State of Florida (EIN# 27-4897042) ("Vendor").

WHEREAS, on April 20, 2020, City and Vendor entered into an Agreement for Airport Janitorial Services (the "Original Agreement"), City of Ocala contract No. AIR/200138, for a term of two (2) years, from April 1, 2020 to March 31, 2022; and

WHEREAS, on December 11, 2020, City and Vendor entered into a First Amendment for the purpose of amending the locations to be serviced; and

WHEREAS, on February 9, 2022, City and Vendor entered into a Second Amendment to extend the Original Agreement for the first of two (2) one-year renewal periods available under the Original Agreement; and

WHEREAS, City and Vendor now desire to enter into this Third Amendment for the purpose of including an additional service location set forth in **Exhibit B – Price Proposal**; and

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Vendor agree as follows:

- 1. **RECITALS**. City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect except for those terms and conditions expressly amended by this Third Amendment.
- AMENDMENT TO EXHIBIT B PRICE PROPOSAL. The document attached to the Original Agreement as Exhibit B – Price Proposal is hereby deleted and replaced, in its entirety, with the document attached to this Third Amendment as Revised Exhibit B – Price Proposal.
- 4. **NOTICES**. All notices, certifications or communications required by this Third Amendment shall be given in writing and shall be deemed delivered when personally served, or when

Except as expressly set forth herein, the Original Agreement shall remain in full force and effect and is not amended or modified.
- 7. **COUNTERPARTS.** This Third Amendment may be executed in counterparts, each of which shall be an original and all of which shall constitute the same instrument.
- 8. **ELECTRONIC SIGNATURE(S).** Vendor, if and by offering an electronic signature in any form whatsoever, will accept and agree to be bound by said electronic signature to all terms and conditions of this Third Amendment. Further, a duplicate or copy of the Third

9. **LEGAL AUTHORITY**.
