

FIRST AMENDMENT TO AGREEMENT TO PROVIDE CONSIGNMENT HYDRAULIC HOSES, FITTINGS, COUPLINGS AND ADAPTERS

THIS FIRST AMENDMENT TO AGREEMENT TO PROVIDE CONSIGNMENT HYDRAULIC HOSES, FITTINGS, COUPLINGS AND ADAPTERS ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), and **HTJ HEFLIN**, **INC**., a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN# 47-2138348) ("Vendor").

WHEREAS, on October 12, 2023, City and Vendor entered into an Agreement to Provide Consignment Hydraulic Hoses, Fittings, Couplings and Adapters (the "Original Agreement"), City of Ocala Contract Number: FAC/230682, for a term of two (2) years, from October 1, 2023 through September 30, 2025; and

WHEREAS, City and Vendor now desire to renew the Original Agreement for the first of two (2) additional one (1) year renewal periods available under the terms of the Original Agreement.

NOW THEREFORE, in consideration of the foregoing recitals, the following mutual covenants and conditions, and other good and valuable consideration, City and Vendor agree as follows:

- 1. **RECITALS.** City and Vendor hereby represent, warrant, and agree that the Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **INCORPORATION OF ORIGINAL AGREEMENT**. The Original Agreement between City and Vendor is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **RENEWAL TERM.** The Original Agreement is hereby renewed for an additional one (1) year term beginning **OCTOBER 1, 2025** and terminating **SEPTEMBER 30, 2026**. Thereafter, the parties acknowledge and agree that there remains the option for the Original Agreement to be renewed for up to **ONE (1)** additional **ONE (1) YEAR** period upon written agreement between the parties.
- 4. COMPENSATION. City shall pay Vendor an amount not to exceed <u>FIFTY THOUSAND AND NO/100 DOLLARS (\$50,000)</u> (the "Contract Sum") over the renewal term as full and complete compensation for the timely and satisfactory performance of services to the City in accordance with the Contract Documents. The pricing in this Agreement may only be adjusted by written amendment executed by both parties.
- 5. **NOTICES**. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:

- 8. **LEGAL AUTHORITY**. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Ocala - Procurement & Contracting (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies

To withdraw your consent with City of Ocala - Procurement & Contracting

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to contracts@ocalafl.org and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent.. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
