



**FIFTH AMENDMENT TO CONSTRUCTION SERVICES AGREEMENT FOR TRANSPORTATION
REHABILITATION IMPROVEMENT PROGRAM ("TRIP") PROJECTS**

THIS FIFTH AMENDMENT TO CONSTRUCTION SERVICES AGREEMENT FOR TRANSPORTATION REHABILITATION IMPROVEMENT PROGRAM ("TRIP") ("Fifth Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City") and **C.W. ROBERTS CONTRACTING, INC.**, a for-profit corporation duly organized and authorized to do business in the state of Florida (EIN: 59-1683951) ("Contractor").

WHEREAS, on May 8, 2023, City and Contractor entered into a Construction Services Agreement for Transportation Rehabilitation Improvement Program ("TRIP") Projects (the "Original Agreement"), City of Ocala Contract Number: CIP/230266 for a term of two (2) years from May 3, 2023, to May 2, 2025; and

WHEREAS, on April 4, 2024, City and Contractor entered into a First Amendment to Construction Services Agreement for Transportation Rehabilitation Improvement Program ("TRIP") Projects (the "First Amendment") amending the total amount of compensation described in the Original Agreement; and

WHEREAS, on May 6, 2024, City and Contractor entered into a Second Amendment to Construction Services Agreement for Transportation Rehabilitation Improvement Program ("TRIP") Projects (the "Second Amendment") to modify the unit pricing schedule by adding line items to Exhibit B – Price Proposal attached to the Original Agreement; and

WHEREAS, on May 12, 2025, City and Contractor entered into a Third Amendment to Agreement for Transportation Rehabilitation Improvement Program ("TRIP") Projects (the "Third Amendment") to renew the Original Agreement, as amended, for the first of two available one-year renewal terms, and to revise the pricing schedule; and

WHEREAS, on June 14, 2026, City and Contractor entered into a Fourth Amendment (the "Fourth Amendment") to Construction Services Agreement for Transportation Rehabilitation Improvement Program ("TRIP") Projects, to extend the Original Agreement, as amended, for the second available one-year renewal term and to further revise the pricing schedule; and

WHEREAS, City and Contractor now desire to further revise Exhibit B – Amended Price Proposal to include additional line items.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City and Contractor agree as follows:

1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
2. **INCORPORATION OF ORIGINAL AGREEMENT.** The Original Agreement between City and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this Fifth Amendment.
3. **AMENDMENT TO EXHIBIT B – PRICE PROPOSAL.** The document attached to the Original Agreement as **Exhibit B – Amended Price Proposal** is hereby deleted and replaced, in its



entirety, with the document attached to this Fifth Amendment as **Amended Exhibit B – Price Proposal**.

4. **NOTICES.** All notices, certifications or communications required by this Fifth Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Further, a duplicate or copy of the Fifth Amendment that contains a duplicated or non-original signature will be treated the same as an original, signed copy of this original Fifth Amendment for all purposes.
8. **LEGAL AUTHORITY.** Each person signing this Fifth Amendment on behalf of either party individually warrants that he or she has full legal power to execute this Fifth Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Fifth Amendment.
