INTERAGENCY AGREEMENT BETWEEN THE OCALA POLICE DEPARTMENT AND THE MARION COUNTY CLERK OF COURTS FOR THE EXCHANGE OF CRIMINAL JUSTICE INFORMATION AND USE OF COMPUTER SYSTEMS

WITNESSETH

- **WHEREAS,** The Ocala Police Department (hereafter referred to as "OPD") is a Criminal Justice agency recognized by the Federal Bureau of Investigations (FBI) and the Florida Department of Law Enforcement (FDLE); and
- **WHEREAS,** The OPD currently maintains certain data systems for the management and storage of records (hereafter referred to as "RECORDS") containing Criminal Justice Information (CJI); and
- **WHEREAS,** The Marion County Clerk of Courts (hereafter referred to as "MCCC") wishes to regularly and routinely receive the RECORDS for the administration of criminal justice;
- **NOW, THEREFORE,** the OPD and the MCCC (hereafter referred to as "THE PARTIES") agree as follows:
 - 1. The MCCC will receive the RECORDS from the OPD via encrypted means, consistent with requirements set forth in the FBI's Criminal Justice Information Services (CJIS) Security Policy, a copy of which is attached to this agreement as Exhibit A. If electronic communications security requirements cannot be met, the RECORDS will be delivered via courier, in printed form.
 - 2. The OPD will provide the RECORDS for criminal justice purposes at no cost to the MCCC.
 - **3.** THE MCCC agrees to abide by the terms and conditions of the Criminal Justice User Agreement executed between the FDLE and the OPD, dated 17DEC2020, a copy of which is attached to this agreement as Exhibit B.
 - 4. The MCCC agrees to abide by all applicable local, state, and federal laws, rules, and regulations, as well as the FBI CJIS Security Policy. The MCCC further agrees to immediately notify the OPD upon the discovery of an MCCC employee misusing or accessing the RECORDS in violation of any of the aforementioned laws, rules, and regulations.

- 5. The MCCC agrees to hold harmless the OPD, its Officers, and its employees from any and all liability relating to or arising from the use of the RECORDS by the Clerk, his Deputies, or his employees.
- **6.** Either party may terminate this agreement with thirty (30) days written notice to the other, except the OPD may terminate this agreement immediately and without notice upon finding the MCCC has violated the terms stated herein.
- **7.** This agreement constitutes the entire agreement between the parties and may not be modified or amended without written agreement executed by THE PARTIES.
