JUDGMENT FOR TAXABLE COSTS

This matter came before the Court on January 3, 2022, on Plaintiffs' Motion to Tax Costs against Defendant. Based upon the pleadings, records, and documents filed by counsel, and the stipulation of counsel, the Court finds that the Motion should be **GRANTED**.

- 1. The Court finds that the taxable legal costs and charges incurred by Plaintiffs are \$67,353.89. Plaintiffs' costs were advanced by Class Counsel, Bowen|Schroth.
- 2. The Court finds that, in accordance with Section 57.041(1), Florida Statutes, Plaintiffs, the prevailing party, shall recover from Defendant, the nonprevailing party, all the prevailing party's taxable legal costs and charges.

IT IS THEREFORE ORDERED that,

- 1. Plaintiffs' Motion to Tax Costs Against Defendant is hereby **GRANTED**.
- 2. Taxable costs incurred in this action, in the amount of \$67,353.89 as set forth in Exhibit "A", attached to Plaintiffs' Motion to Tax Costs Against Defendant, plus interest at the legal rate of 4.25% from the date this judgment is signed adjusted annually on January 1 of each year in accordance with the interest rate in effect on that date as set by the Chief Financial Officer, are hereby taxed against Defendant, the City of Ocala, for which let execution issue.
- 3. The judgment debtor shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the

judgment creditor's attorney, or the judgment creditor if the judgment creditor is not represented by an attorney, within 45 days from the date of this final judgment, unless the final judgment is satisfied, or post-judgment discovery is stayed.

Jurisdiction of this case is retained to enter other judgments taxing costs against Defendant for additional taxable costs Plaintiffs incur in this case, to enter further orders that are proper to compel the judgment debtor to complete form 1.977, including all required attachments, and serve it on the judgment creditor's attorney, or the judgment creditor if the judgment creditor is not represented by an attorney, and for any other necessary actions related to this case.
