

SECOND AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG HOUSING REHABILITATION BETWEEN THE ITY OF OCALA, THE HOMEOWNER, AND THE CITY SELECTED CONTRACTOR

THIS SECOND AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG HOUSING REHABILITATION BETWEEN THE ITY OF OCALA, THE HOMEOWNER, AND THE CITY SELECTED CONTRACTOR ("Second Amendment") is entered into by and between the <u>CITY OF OCALA</u>, a Florida municipal corporation ("City"), acting as agent for <u>ROSA GRAY CROCKETT</u> ("Owner"), and <u>BRUCE WAYNE WILEY, LLC</u>, a Florida Limited Liability Company (EIN# 47-1267940), located at 2107 NE 9th Street, Ocala, Florida 34470, ("Contractor").

WHEREAS, on December 14, 2021, City, Owner, and Contractor entered into an Agreement for SHIP/HOME/CDBG Housing Rehabilitation (the "Original Agreement"), City of Ocala Contract No.: CDS/210967; and

WHEREAS, City, Owner, and Contractor subsequently entered into a First Amendment to the Agreement for SHIP/HOME/CDBG Housing Rehabilitation (the "First Amendment") to reflect an increase in the Contract Price necessitated by a Work Change Directive issued on February 1, 2022; and

WHEREAS, City, Owner, and Contractor now desire to amend the Original Agreement to reflect an increase in the Contract Price necessitated by a Work Change Directive issued February 24, 2022, and attached hereto as **Exhibit A – Work Change Directive**.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City, Owner and Contractor agree as follows:

- RECITALS. City and Vendor hereby represent and warrant that the Recitals set forth above are true and correct.
- INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City,
 Owner, and Contractor is hereby incorporated by reference as if set forth herein in its entirety
 and remains in full force and effect, except for those terms and conditions expressly amended
 by this Second Amendment.
- AMENDMENT TO PARAGRAPH 2 CONTRACT PRICE. The language contained in Paragraph 2 – Contract Price of the Original Agreement is hereby deleted and replaced, in its entirety, with the following:

CONTRACT PRICE. City shall pay Contractor, on behalf of the Owner, for the performance of the work, and in accordance with the contract documents, a Total Price in the amount of \$74,996.03 (SEVENTY-FOUR THOUSAND, NINE HUNDRED NINETY-SIX DOLLARS AND 03/100). It is understood the amounts to be paid will



be for satisfactory work actually completed rather than the estimated prices. Payments are to be made, at the unit price and/or lump sums specified for the various items in the Contractor's proposal as provided in the specifications.

- A. The modified Contract Price represents the sum of the original bid price of \$67,949.03, the total cost of Change Order #1, and the total cost of Change Order #2 as set forth in Exhibit A Work Change Directive.
- 4. NOTICES. All notices, certifications or communications required by this Second Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:




