

FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG HOUSING REHABILITATION-WINDOW INSTALLATION & PLUMBING

THIS FIRST AMENDMENT TO AGREEMENT FOR SHIP/HOME/CDBG HOUSING REHABILITATION – WINDOW INSTALLATION & PLUMBING, ("First Amendment") is entered into by and between the **CITY OF OCALA**, a Florida municipal corporation ("City"), **ROSE LEE BROWN** ("Owner"), and STEJACK, LLC., a limited liability company duly organized and authorized to do business in the state of Florida (EIN# 99-3286876) ("Contractor").

WHEREAS, on April 14, 2025, City, Owner, and Contractor entered into an Agreement for SHIP/HOME/CDBG Housing Rehabilitation - Window Installation & Plumbing (the "Original Agreement"), City of Ocala Contract No.: CDS/250340A; and

WHEREAS, City, Owner, and Contractor now desire to amend the Original Agreement to extend the Time for Performance necessitated by a Work Change Directive, issued July 15, 2025, and attached hereto as Exhibit A - Work Change Directive.

NOW THEREFORE, in consideration of each of the foregoing recitals and the following mutual covenants, conditions and other good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, City, Owner and Contractor agree as follows:

- 1. **RECITALS.** City and Contractor hereby represent and warrant that the Recitals set forth above are true and correct.
- 2. INCORPORATION OF ORIGINAL AGREEMENT. The Original Agreement between City, Owner, and Contractor, as amended, is hereby incorporated by reference as if set forth herein in its entirety and remains in full force and effect, except for those terms and conditions expressly amended by this First Amendment.
- 3. **AMENDMENT TO PARAGRAPH 6 B TIME FOR PERFORMANCE.** The language contained in Paragraph 6 B – Time for Performance of the Original Agreement is hereby deleted and replaced with the following (all remaining sections of Paragraph 6 – Time for Performance remain in effect):

All work shall be completed by Contractor in a manner satisfactory to the City Project Manager by AUGUST 6, 2025, and ready for final payment within ten (10) days of final completion.

4. **NOTICES**. All notices, certifications or communications required by this First Amendment shall be given in writing and shall be deemed delivered when personally served, or when received if by facsimile transmission with a confirming copy mailed by registered or certified mail, postage prepaid, return receipt requested. Notices can be concurrently delivered by email. All notices shall be addressed to the respective parties as follows:

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

Getting paper copies
