### Text of Legislative File 2023-0146

Approve additional expenditures under three-year contracts with UniFirst Corporation and Cintas Corporation for citywide uniform services for an increased total contract expenditure amount of \$250,515

#### **BACKGROUND:**

On October 20, 2020, City Council approved three-year contracts with UniFirst Corporation ("UniFirst") and Cintas Corporation ("Cintas") (collectively, Contract No.: COO/200511) for the provision of uniform services for thirteen (13) City departments/divisions with an estimated aggregate expenditure of \$153,514.92. Contract No. COO/200511 will expire on October 31, 2023.

UniFirst is located in Ocala and Cintas is located in Gainesville, Florida. Both vendors provide dedicated drivers, identical pick-up and delivery service frequencies, and the same garment selection options for the employees of the utilizing departments. The utilization of a multi-vendor citywide contracting arrangement will allow for more competitive bidding in future solicitations.

#### FINDINGS AND CONCLUSIONS:

Since contract inception, uniform services under Contract No.: COO/200511 have totaled \$134,262.76. Due to increased staffing numbers in the thirteen (13) departments/divisions utilizing Contract No.: COO/200511, Procurement staff anticipates the City will expend an additional \$97,000 to cover current and anticipated uniform services through the end of the contract term; thereby necessitating an increase in the expenditure threshold.

#### **FISCAL IMPACT:**

User departments have budgeted for uniforms and accessories in their individual fiscal year budgets.

The procurement of goods and services under these Agreements have been made in compliance with the City's Procurement Policy.
